ORDER:

In the letter 1st read above, Government of India have approved a new scheme "Beti Bachao Beti Padhao" to celebrate the Girl child and enable her education in 100 selected districts on pilot basis across the country including the district of Cuddalore in Tamilnadu.

The scheme aims to address the issue of decline in Child Sex Ratio (CSR) through a mass campaign across the country targeted at changing societal mindset and

creating awareness about the criticality of the issue, focused intervention and multi-sectoral action in 100 districts with low Child Sex Ratio. The goal of empowering the girl child aims at (i) preventing gender biased sex selective elimination (ii) ensuring survival and protection of the girl child and (iii) ensuring education and participation of the girl child. Government of India have also issued Guidelines towards the implementation of Beti Bachao Beti Padhao Scheme.

- 2. In the letter 2nd read above, Government have nominated the Deputy Director, (Child Welfare), Office of Commissioner of Social Welfare as Coordinator for the mass campaign of "Beti Bachao Beti Padhao" Scheme to be implemented in the district of Cuddalore.
- 3. In the letter 4th read above, necessary District Action Plan has been proposed and sent to Government of India to sanction funds in accordance with the proposal of the District Collector, Cuddalore.
- 4. In the letter 5th read above, Government of India have released a sum of ₹ 18,14,000 towards the implementation of "Beti Bachao Beti Padhao (BBBP)" scheme for the period of 01.03.2015 to 31.03.2015 during the year 2014-2015. Further, Government of India have also revalidated the above amount to utilize for the implementation of "Beti Bachao Beti Padhao" Scheme during 2015-2016 as per schematic norms
- 5. In the letter 6th read above, the Director, Integrated Child Development Services Scheme has sent proposal stating that the amount of grants-in-aid includes cost of activities such as Inter-Sectoral Consultation meeting and meeting of State Task Force, Training and Capacity Building, sensitization programme, Innovation and Awareness generation Activities, Monitoring and Evaluation at State/District level and sectoral activities. The Director, Integrated Child Development Services Scheme has sent the component wise expenditure for the period of one month during 2015-2016 as detailed below and requested the Government to issue necessary orders.

- 6. After careful examination, Government issues the following orders:-
- i. Government accord sanction for a sum of ₹18,14,000 towards the implementation of "Beti Bachao Beti Padhao (BBBP)" to celebrate Girl child and enable her education in Cuddalore District of Tamilnadu for the period of one month during the year 2015-2016.
- ii. The Director, Integrated Child Development Services Scheme is authorized to implement the scheme in coordination with Commissioner of Social Welfare to the tune of ₹7.33 lakh for a period of one month during 2015-2016 for the State level activities detailed in para 5(I) above.
- iii. The Director, Integrated Child Development Services Scheme is authorized to implement the scheme in coordination with District Collector, Cuddalore to the tune of ₹ 10.81 lakh for a period of one month during 2015-2016 for the District Level Activities detailed in para 5(II) above.
- iv. The Commissioner of Social Welfare is authorized to draw and incur the amount of ₹7.33 lakh for carrying out the State level activities since the Deputy Director (Child welfare) is the nodal officer for the scheme.
- v. The Commissioner of Social Welfare is authorized to draw and disburse the amount of ₹10.81 lakh to the District Collector, Cuddalore to carry out the District Level activities approved by Government of India.

- vi. The Commissioner of Social Welfare and the District Collector, Cuddalore are authorized to carry out Head-wise and component-wise readjustment, wherever actually required within the total approved cost under this scheme and also permitted them to utilize the savings, if any, in any one of the activities/components, to incur expenditure at State level/ District level as per Government of India guidelines under the scheme within the overall budget limit.
- vii. The Commissioner of Social Welfare is permitted to draw the amount sanctioned in para 6(i) above as advance under Article 99 of Tamil Nadu Financial Code Volume I towards the implementation of the scheme.
- 7. The expenditure sanctioned in para 6(i) above shall be debited under the following newly opened Head of Account:-

"2235-Social security and Welfare-02-Social Welfare-200-other programme-schemes in the Twelfth Five Year Plan – III Centrally Sponsored Scheme-SB-"Beti Bachao Beti Padhao" to celebrate Girl Child and enable her education – 09- grants-in-aid, 03-grants for specific schemes" (D.P.Code No.2235-02-200 SB 09)

- 8. The Commissioner of Social Welfare is the Estimating. Reconciling and Controlling Authority for the above new head of account. The Pay and Accounts Officers/Treasury Officers concerned are requested to open this new head of account in their accounts.
- 9. Necessary funds will be provided in RE/FMA 2015-2016, the Commissioner of Social Welfare is authorized to draw and disburse the amount sanctioned in para 6(i) above. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2015-2016. The Commissioner of Social Welfare is directed to include this item of expenditure while sending the proposal for RE/FMA 2015-2016 and also send draft explanatory note for inclusion of the expenditure in the Supplementary Estimate to Government in Finance (SW) Department without fail.
- 10. This order issues with the concurrence of Finance Department vide its U.O.No.27428/Fin(SW)/2015, Dated 24.06.2015 and Additional Sanction Ledger No.456 (Four Hundred and fifty six).
