ORDER:

The Principal Secretary / Special Commissioner, Integrated Child Development Services in her letter read above has stated the Integrated Child Development Services Scheme is designed to promote the holistic development of children under 6 years by strengthening the capacities of the caregivers and the community and by improved access to basic services at the community level. Its programme for the age of three to six years children in the Anganwadi centre is directed towards providing and ensuring a natural, joyful and stimulating environment, with emphasis on necessary inputs for optimal growth and development.

2. The Principal Secretary / Special Commissioner, Integrated Child Development Services has also stated that in order to make the Anganwadi Centres attractive and to ensure a healthy atmosphere it is imperative that the centre housed in Government owned buildings need to be colour washed now and then. During the year 2006 only 1000 Anganwadi Centre functioning under Integrated Child Development Services have been colour washed. Now it is proposed to colour wash 2000

Anganwadi Centres functioning in Government owned buildings during 2012-13 at a cost of Rs.2000/- per Anganwadi Centres totalling to an amount of Rs.40.00 lakh.

3. The Principal Secretary / Special Commissioner, Integrated Child Development Services has therefore requested the Government to sanction a sum of Rs.40.00 lakh as non-recurring expenditure towards Uniform colour washing to 2000 Anganwadi Centres and the break up details of the above expenditure is as follows:

Cost for Colour Painting per Center : Non-Recurring Cost Rs.2000 / -

Total Amount required (2000 x Rs.2000) : Rs.40,00,000/-

4. After careful examination of the proposal of the Principal Secretary / Special Commissioner, Integrated Child Development Services the Government accord sanction for a sum of Rs.40.00 lakh (Rupees forty lakh only) as non-recurring expenditure towards providing Uniform colour washing to 2000 Anganwadi centres at Rs.2000/- per Anganwadi centre, under Part II Scheme for the year 2012-2013.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-
