ORDER:

The Principal Secretary / Special Commissioner, Integrated Child Development Services in her letter read above has stated that the Laptop is small and easy to handle and facilitate the rapid acquisition and transmission of correspondences, information and data could be made possible at any time at any place. It does not require well furnished rooms, air condition facilities and other fixtures, the expenditure to be incurred towards the purpose could be saved.

2. The Principal Secretary / Special Commissioner, Integrated Child Development Services has also stated that the functional features of Laptop Computer are similar to the Desktop computer and as such it is worth procuring the Laptop Computer. Instead of carrying the voluminous record and bunch of hard copies to any official meetings, conferences, forums etc, it would be worthwhile to take one Laptop fed with adequate details, as it facilitate easier collections and supply of information according to the required standard of precision. As Integrated Child Development Services Scheme is a centrally sponsored scheme and officials have to go to New Delhi frequently , it is easier to carry Laptops for PowerPoint presentation. Besides, the presentation and interaction during the forums could be made easy with usage of Laptop Computer. Considering the utility point of view of the Laptop computer as specified above, it has been planned to provide one Laptop Computer to the Commissionerate of Integrated Child Development Services Scheme, Taramani, Chennai.

3. The Principal Secretary / Special Commissioner, Integrated Child Development Services has therefore requested the Government to sanction a sum of Rs.70,000/- as non-recurring expenditure towards Providing One Laptop Computer to Commissionerate of Integrated Child Development Services Scheme, Tharamani, Chennai-113

4. After careful examination of the proposal of the Principal Secretary / Special Commissioner, Integrated Child Development Services, the Government accord sanction for a sum of Rs.70,000/- (Rupees Seventy thousand only) as non-recurring expenditure towards purchase of one Laptop Computer to the Commissionerate of Integrated Child Development Services Scheme, Taramani, Chennai -113 under Part II Scheme for the year 2012-2013.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

6. The Principal Secretary / Special Commissioner, Integrated Child Development Services is instructed to adhere the financial procedure while procuring the Laptop computer utilizing the amount sanctioned in para 4 above and furnish the Utilisation Certificate to Government early.
