Social Welfare and Nutritious Meal Programme - Integrated Child Development Services Scheme -Utilization of the remaining 50% fund available in Budget Estimate 2015-2016 towards providing Weaning Food containing amylase activity as Supplementary Nutrition to Integrated Child Development Services Scheme beneficiaries for the year 2015-2016 permission - Accorded - Orders - Issued.

Weaning Food containing amylase activity as Supplementary Nutrition is being provided to the children in the age group of 6 months to 36 months, Pregnant and Lactating mothers under Integrated Child Development Services Scheme beneficiaries in the sharing pattern of 50:50 between Government of India and the State. The Director, Integrated Child Development Services Scheme has used to incur the expenditure provided in the Budget Estimate every year towards the procurement and supply of Weaning Food as Supplementary Nutrition to the Integrated Child Development Services Scheme beneficiaries.

- 2. In the Budget Estimate, a sum of ₹433.85 crore has been allocated in Budget Estimate 2015-2016 towards providing Weaning Food containing amylase activity as Supplementary Nutrition to Integrated Child Development Services Scheme beneficiaries. Of which 50% of the amount (ie) ₹216.92 crore has already been utilized and the balance amount has not been able to be utilized since the vote on account has not yet been passed in Tamilnadu Legislative Assembly.
- 3. In the letter 2nd cited, a sum of ₹1471.80 crore has been proposed in Annual Programme Implementation Plan 2015-2016 inclusive of ₹591.40 crore (Government of India share ₹297.28 crore and State share ₹294.11 crore) towards providing Supplementary Nutrition inclusive of ₹634.12 lakh towards provision of Supplementary Nutrition to the children in JE affected 5 Districts and sent to Government of India.
- 4. In the letters 3rd cited, Government of India have released a sum of ₹ 125.05 crore as grants-in-aid for providing Supplementary Nutrition to Integrated Child Development Services Scheme beneficiaries in the sharing pattern of 50:50 for the year 2015-2016.
- 5. After careful examination, Government permit the Director, Integrated Child Development Services Scheme to utilise the balance 50% amount of ₹216.92 crore (Rupees two crore sixteen lakh and ninety two thousand only) under the following Heads of Account available in Budget Estimate 2015-2016 towards providing weaning food as Supplementary Nutrition to Integrated Child Development Services Scheme beneficiaries for the year 2015-2016 to ensure uninterrupted supply of weaning food to the children in the age group of 6-36 months, pregnant women and lactating mothers under Integrated Child Development Services Scheme by relaxing the Quarterly Control of Appropriation system for the year 2015-2016.
