ORDER:

In the letter first read above, the Government of India, have approved a new scheme viz: Indira Gandhi Matritva Sahyog Yojana (IGMSY), a Conditional Maternity Benefit (CMB) Scheme for pregnant and lactating women on pilot basis in 52 selected districts across the country by providing cash incentives for improved health and nutrition to pregnant and lactating mothers by using the Integrated Child Development Services platform. In the above scheme, the beneficiaries (Pregnant and lactating women) will be paid Rs.4,000/- in three instalments i.e. Rs.1,500/- at the end of second trimester, Rs.1,500/ will be paid 3 months after delivery and Rs.1,000/- will be paid 6 months after delivery on fulfilling certain specific conditions related to maternal and child health as approved by Government of India. The Government of India has approved two districts i.e. Cuddalore and Erode for the implementation of the above new scheme in Tamil Nadu on pilot basis.

- 2. In the letter 2nd read above, the Government of India has accorded its concurrence to implement the Indira Gandhi Matritva Sahyog Yojana scheme of the Government of India using the Integrated Child Development Services platform in synergy with the Dr.Muthulakshmi Reddy Maternity Benefit Scheme of the State Government and to give the maximum financial benefit to the Pregnant and Lactating Mothers so that all the targeted beneficiaries under the Indira Gandhi Matritva Sahyog Yojana in Erode and Cuddalore districts will be given financial assistance of Rs.12,000/-i.e. Rs.4,000/- from Government of India fund and Rs.8,000/- from State Government fund and will be released in three instalments as per the conditions envisaged in the Indira Gandhi Matritva Sahyog Yojana.
- 3. Based on the Government of India release, in the Government order 4th read above, sanction was accorded for a sum of Rs.1357.08 lakh towards the implementation of IGMSY Scheme in Cuddalore and Erode Districts.
- 4. In the Government Order 5th read above amendment orders were issued based on the Utilization Certificate furnished by the Director of Public Health and Preventive Medicine for adjusting the sanctioned amount in Health Department's Head of Account.
- 5. In the letter 7th read above, the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme has stated in her proposal that Government of India have so far released Rs.1599.155 lakh towards IGMSY Scheme and State Government have released Rs.1357.08 lakh under IGMSY for 2011-2012. Based on the Utilisation Certificate by the Director of Public Health and Preventive Medicine, Rs.1020.745 lakh have been sent to Government of India and the same have been adjusted by the Commissionerate of Integrated Child Development Services Scheme vide Government order 5th read above in the relevant Heads of Health Department. Hence there is a balance of Rs.578.405 lakh available with the State Government out of the Government of India grants so far released. Government of India have accorded revalidation of funds of Rs.578.405 lakh for incurring the expenditure in the year 2012-2013. Further it is informed that Utilization Certificate and Statement of Expenditure for the year 2012-2013 up to December 2012 to the tune of Rs.1341.94 lakh have been sent to Government of India vide D.O.Letter No.15385/HM1/2010, Dated 26.02.2013 for reimbursing the same to the Director of Public Health and Preventive Medicine. Hence, the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme has requested the Government to sanction a sum of Rs.578.40 lakh towards the cash benefit to the 42,092 beneficiaries in 3 instalments under IGMSY in Cuddalore and Erode Districts in synergy with Dr.Muthulakshmi Reddy Maternity Benefit Scheme from April 2012 to September 2012 as per the Utilization Certificate and Statement of Expenditure submitted by the Director of Public Health and Preventive Medicine and also requested the Government to permit her to adjust the above sanctioned amount of Rs.578.40 lakh similar to the amount adjusted for the year 2011-2012 vide Government order 5th read above under IGMSY. In the letter 6th read above, the Government of India have conveyed the approval of the revalidation for the unspent balance available for Rs.578.40 lakh released in 2011-2012 for the use in the year 2012-2013 for the same purpose.

- 6. After careful examination the Government have accepted the proposal of Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme, and decided to issue the following orders:
 - i. Government accord sanction for Rs.578.40 lakh (Rupees five crore seventy eight lakh and forty thousand only) towards the cash benefit to the 42,092 beneficiaries in 3 installments for the implementation of IGMSY Scheme in Cuddalore and Erode District based on the Utilization Certificate submitted by Director of Public Health and Preventive Medicine for the year 2012-2013 from April 2012 to September 2012 under the following Heads of Account:-
 - (a) General beneficiary Rs.462.72 lakh (80%) "2236 Nutrition – 02 – Distribution of nutritious food and beverages – 101. Special Nutrition Programmes Schemes in the Twelfth Five year plan – III Centrally Sponsored – SK – Indira Gandhi Matritva Sahyog Yojana (IGMSY) Maternity Benefit Scheme -09 – Grants in aid – 03 – Grants for Specific Scheme."  - (b) Beneficiaries under Special Component Plan Rs.109.90 lakh (19%) "2236 Nutrition – 02 Distribution of nutrition food and beverages – 789 – Special Component Plan for scheduled castes – Schemes in the Twelfth Five year plan – III – Centrally Sponsored – SA Indira Gandhi Matritva Sahyog Yojana (IGMSY) Maternity Benefit Scheme under Special Component plan – 09 Grants in aid – 03 – Grants for Specific Schemes."  - (c) Beneficiaries for Tribal Sub Plan Rs.5.78 lakh (1%) "2236 Nutrition – 02 Distribution of nutritious Food and Beverages 796 – Tribal Sub Plan – Schemes in the Twelfth five year plan-III –Centrally Sponsored – SA – Indira Gandhi Matritva Sahyog Yojana (IGMSY) – Maternity Benefit Scheme under Tribal Sub Plan – 09 – Grants in Aid – 03 – Grants for Specific schemes." (DPC: 2236 02 796 SA 0936)
 - ii. The Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme is permitted to present the adjustment bill for the amount sanctioned in para 6(i) above by crediting the amount certified by Director of Public Health and Preventive Medicine under the following Heads of Account:-

The Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme is requested to include the above expenditure in RE/FMA 2013-2014 while sending the proposal to Finance (Social Welfare) Department without fail and is also requested to include the above expenditure in Supplementary Estimates 2013-2014 at the appropriate time.
- iv. The Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme is permitted to furnish Utilisation Certificate and Statement of Expenditure for the year 2012-2013 from April 2012 to September 2012 to Government of India, based on the certificate furnished by the Director of Public Health and Preventive Medicine on the number of beneficiaries disbursed with cash assistance under Dr.Muthulakshmi Reddy Maternity Benefit Scheme in Cuddalore and Erode Districts during the year 2012-2013 from April 2012 to September 2012.
- v. The Utilisation Certificate and Statement of Expenditure giving the Physical and financial performance may be sent to Government of India by the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme based on the Utilisation Certificate and Statement of Expenditure furnished by the Director of Public Health and Preventive Medicine.
- vi. The Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme is permitted to provide name seal, with the name of "Indira Gandhi Matritva Sahyog Yojana" to all the Block Medical Officers in Cuddalore

and Erode Districts though the Director of Public Health and Preventive Medicine for affixing on the documents related to Dr.Muthulakshmi Reddy Maternity Benefit Scheme from the funds sanctioned for the implementation of Indira Gandhi Matritva Sahyog Yojana Scheme.
