ORDER:

In the letter first read above, the Director of Social Defence has sent a proposal for constituting a Social Audit Committee as per Section 36 of the Juvenile Justice Act for conducting Social Audit of implementation of Juvenile Justice Act in the State.

2. The Government after careful examination of the proposal of the Director of Social Defence has decided to constitute the Social Audit Committee in pursuance of Section 36 of Juvenile Justice (Care and Protection of Children) Act, 2000 with the following composition:-

2.	Director of Social Defence	Member, Secretary
3.	Programme Manager, State Adoption Resource Agency	Member

4.	Joint Secretary, Tamil Nadu Social Welfare Board	Member
5.	<u>NGO Partner/representative of Child Line Foundation</u> Head for South Regional Resource Centre, Child Line India Foundation.	Member
6.	<u>Expert (Mental Health)</u> Asst. Director, Institute of Mental Health, Chennai or his representative.	Member

7.	<u>Expert (Child Care & Protection), NGO</u> The Honorary Secretary, ICCW, Chennai (Collaborative Org. of Child Line)	Member

* The tenure of the Non-Official member shall be one year from the date of appointment.

3. The above Social Audit Committee of the State shall perform the following functions:-

- I. To Monitor and evaluate the implementation of the JJ Act annually by reviewing matter concerning establishment, including pendency of cases at Juvenile Justice Board or Child Welfare Committee and Functioning of Special Juvenile Police Unit.
- II. Ensuring of Child friendly administration of Juvenile Justice.
- III. Review functioning of Child Care Institutions, adoption agencies covering each District/city and also non-institutional care program including After care being District/city and also non-institutional care program including After care being implemented under the ICPS in the State.
- IV. Submission of annual Social Audit Report to the State Government and also to the Ministry of Women and Child Development, Government of India.

- V. Monitoring of Registration of all Children homes under the Juvenile Justice Act.
- VI. Effective implementation of Foster Care/ Sponsorship etc.,
- VII. Implementation of Programmes in consonance with the District Need Assessment.
- VIII. Any other matter concerning effective implementation of the Act in the State.

4. The Committee shall meet as and when required and atleast once in four months.
