ORDER:

In the Government Order 1st read above, Government have issued orders to convert 318 rural blocks covered by World Bank assisted Tamilnadu Integrated Nutrition Project - II, as projects under World Bank - ICDS III implemented by the "Project Coordinator, World Bank assisted ICDS – III".

- 2. In the Government Order 2nd read above, Government have issued orders for converting existing 318 Tamilnadu Integrated Nutrition Projects (TINP) into General Integrated Child Development projects inclusive of existing 116 General ICDS Projects under World Bank-Integrated Child Development Services Scheme III. Further, in 2003 both projects (318+116) were brought under the single Head of Department, i.e., Integrated Child Development Services Scheme headed by the then Project Coordinator and now the Director cum Mission Director.
- 3. In the Government Order 3rd read above, Government have issued orders to merge 113 ICDS (General) projects, implemented by the Director of Social Welfare with the World Bank assisted Integrated Child Development Services Scheme III.
- 4. In the Government Order 6th read above, Government have issued orders towards closing of the World Bank assisted Integrated Child Development Services Scheme III from 31.03.2006. From 01.04.2006, the erstwhile the ICDS III projects were brought under the ICDS (General) scheme. Consequently, the Heads of Department was re-designated as the "Director of ICDS Scheme".
- 5. In the Letter 7th read above, while revising the staffing pattern of Integrated Child Development Services Scheme State and District Cell, Government of India have communicated and approved the staffing pattern for State Cell i.e. Directorate of Integrated Child Development Services Scheme are 44 No of posts inclusive of Two posts of Joint Director.

- 6. In the Government Order 8th read above, Government accorded sanction for further continuance of the temporary posts originally sanctioned in G.O. 2nd read above and further continued in G.O. 4th read above and amended in Government Letter 5th read above for the period from 01.04.2007 to 31.12.2009.
- 7. In the Government Orders 13th and 14th read above, Government have accorded sanction for further continuance of 54,352 temporary posts for the period from 01.01.2012 to 31.12.2013 which were lastly continued in Government Order 10th read above.
- 8. In the Letter 11th read above, Government of India have modified the Guidelines issued in the Letter 7th read above by incorporating the following:
 - 8(vii) "Posts sanctioned earlier by Government of India, which do not find place in the latest staffing pattern issued vide this Ministry's letter dated 8.05.2009, may henceforth, not be filled up as and when they fall vacant"
- 9. In the Government Order 12th read above, sanction was accorded for further continuance of 48,234 temporary posts inclusive of 4 Joint Coordinators for the period from 1.1.2010 to 31.12.2012 which were lastly continued in G.O. 8th read above and 9th read above inclusive of 74 Supernumerary posts of Anganwadi Workers.
- 10. In Government Letter 15th read above, Government approval was accorded for the proposed 65 regular posts in the Directorate of Integrated Child Development Services Scheme inclusive of Two posts of Joint Director which is less than the existing sanctioned strength under restructured pattern of Integrated Child Development Services Scheme.
- 11. In the letter 16th read above, the Director, Integrated Child Development Services Scheme has sent proposal to issue single orders on further continuance of 1,08,041 temporary posts inclusive of Two posts of Joint Director in the existing posts of Joint Coordinator which is under consideration of the Government. A representation with full justification to retain the 75 posts was sent to Government of India and in the Letter F.No.14-9/2005-CD-1, Ministry of Women and Child Development, Dated 09.03.2010 Government of India have accepted/approved to operate with the existing staff strength.
- 12. In the Letter 17th read above, the Director, Integrated Child Development Services Scheme has sent proposal stating that Government of India have approved/permitted 75 posts for the State Project Monitoring Unit i.e. Directorate of Integrated Child Development Services Scheme, which includes four posts of Joint Coordinator. Meanwhile, Government of India have approved only 44 posts for the State Project Monitoring Unit inclusive of only two posts of Joint Director as against existing four posts of Joint Coordinator. It has also been instructed that any deviation with the post sanction, Government of India may be represented with full justification. Accordingly, necessary justification has been sent to Government of India for the retention of 75 posts for the State Project Monitoring Unit. Meantime, Government of

India have restructured the Integrated Child Development Services Scheme in Mission Mode by sanctioning 21 posts additionally. Hence, the total sanctioned strength for the State Project Monitoring Unit will be 65 as against 75. The same proposal has already been placed in the State level Empowered Committee which has also been approved.

- 13. Hence, the Director, Integrated Child Development Services Scheme has stated that Department of Integrated Child Development Services Scheme is already sanctioned with four Joint Coordinator posts and necessary continuance of the four Joint Coordinator posts are also available as on date. Since Government of India have sanctioned only two posts of Joint Director for Integrated Child Development Services Scheme of Tamilnadu which was also approved by the State Empowered Programme Committee, two posts of Joint Director viz. Joint Director (Administration) and Joint Director (Scheme) may be filled immediately. Even though, the nomenclature of the Head of Department was duly changed as Director/Commissioner accordingly time to time, from the nomenclature of Project Coordinator, the nomenclature of Joint Coordinators may also be changed as Joint Directors so as to fill up the posts which are vacant till now. Further, he has stated that considering the overload/volume of work to the employees and subsequent review the vacancy position by Government of India. the Director, Integrated Child Development Services Scheme has requested the Government to fill up two posts of Joint Director for effective implementation of the Scheme.
 - 14. After careful examination, Government issues the following orders:
 - i. To re-designate existing two number of vacant posts of Joint Coordinator as Joint Directors which carries identical scale of pay with Grade Pay of ₹7,600 under Integrated Child Development Services Scheme.
 - Revival orders for the above posts with effect from the date of vacancy will be issued separately wherein the further continuation proposal is considered.
 - iii. The Social Welfare and Nutritious Meal Programme (SW-1) Department is requested to initiate necessary action towards filling up the two posts of Joint Director under Integrated Child Development Services Scheme as approved in para 14(i) above immediately, so as to avoid further issuance of revival orders
- 15. This order issues with the concurrence of Finance Department vide its U.O. No.50568/Fin(SW)/2015, Dated: 09.09.2015.
