ORDER:-

In the Government Order first read above, the Government have sanctioned a sum of ₹380.39 lakh in the sharing pattern of 60:40 between Government of India and State Government to carry out various activities under the component of Monitoring and Evaluation for the year 2015-2016.

- 2. In the letter second read above, the Government of India have approved the Annual Programme Implementation Plan 2017-2018 inclusive of ₹544.39 lakh under Monitoring and Evaluation component.
- 3. In the letters third read above, the Government of India have released a sum of ₹262.40 crore of Grants in aid as its 60% share for the State of Tamilnadu towards the implementation of Integrated Child Development Services activities for the year 2017-2018.
- 4. In the letters fourth read above, the Director cum Mission Director, Integrated Child Development Services has sent proposal to accord sanction to the tune of ₹413.08 lakh and permission to carry out the following activities under the Monitoring and Evaluation of Integrated Child Development Services for the year 2017-2018.

After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, Government accord sanction for a sum of ₹407.08 lakh (Rupees four crore seven lakh and eight thousand only) to carry out the activities as detailed in Annexure-I to this order under Monitoring and Evaluation component of Integrated Child Development Services in the sharing pattern of 60:40 (Government of India share of ₹244.24 lakh and State Share of ₹162.83 lakh) subject to following conditions:
 - i. The Director cum Mission Director, Integrated Child Development Services is permitted to draw and incur the amount sanctioned above as advance under Article 99 of the Tamilnadu Financial Code Volume-1 and necessary adjustments should be done within the stipulated time.
 - ii. Advertisement charges for the open tender shall be followed as per Tamilnadu Tender Transparency Act, 1998 and Rules 2000 for printing of registers as per specification detailed in Annexure-II to this order under the allotted budget.
 - iii. IT Peripherals should be procured through GeM portal by following the Guidelines and rules existing in force.
 - iv. The Director cum Mission Director, Integrated Child Development Services is directed to follow the Guidelines of Government of India and to submit the Utilization Certificate within stipulated time.
 - v. The Director cum Mission Director, Integrated Child Development Services is permitted to hire consultant for Monitoring & Evaluation as per Government of India norms.
- 6. The expenditure sanctioned in para 5 above shall be debited under the following Heads of Account.
