ORDER:

In the letter 1st read above, Government of India have stated that the training on Early Childhood Care and Education is to be conducted in a cascade model at three levels, first by experts (National Institute of Public Cooperation and Child Development), Second by State Level Master Trainers (SLMTs) and the third level by District Level Master Trainers (DLMTs) and also approved the financial norms for training to District Level Master Trainers and Anganwadi Workers for Early Childhood Care and Education.

2. In the letter 2nd read above, Government of India have released Grant-in-Aid of ₹ 193.59 lakh as 1st instalment to Tamil Nadu for imparting Early Childhood Care and Education (Phase-I) Training under ICDS Scheme in the fund sharing

pattern of 50:50 to conduct Level-2 Training for Supervisors (DLMTs) and Level-1 Training for Anganwadi Workers. In the first instance, 25% on the 50% Government of India share have been received (i.e.) out of ₹774.35 lakh, only ₹ 193.59 lakh has been released.

- 3. In the letters 3rd read above, Government of India have modified the existing sharing ratio for all components of Integrated Child Development Services Scheme, except Supplementary Nutrition (SNP), as 60:40 between Centre and States and the cost sharing ratio for Supplementary Nutrition Programme will remain unchanged/same at 50:50.
- 4. In the letter 4th read above, Government of India had released the balance of 10% share of its 1st instalment to the tune of ₹38.72 lakh, in the revised cost sharing ratio 60:40 instead of 50:50.
- 5. In the G.O. 5th read above, Government have sanctioned a sum of ₹387.20 lakh (inclusive of both State & Central share) for conducting the Level-1 & 2 of the ECCE Training Programme at State/District/Project/Sector Level. Based on the proposed batches, the training programmes have been conducted and completed. After completion of the training programmes, the Utilization Certificate and Statement of Expenditure in the prescribed format has already been sent to Government of India.
- 6. In the letters 6th read above, the Director, Integrated Child Development Services Scheme has stated that the non-formal Pre-School Education (PSE) / Early Childhood Care and Education (ECCE) under the strengthened package of services is a crucial component under ICDS. It aims at holistic development of young children. The Pre-School Education / Early Childhood Care and Education under ICDS is imparted through a play based and activity based approach. A developmental and age appropriate Annual Contextualized Curriculum has been designed by our State, Aadi Padi Vilayadu Pappa (APVP) based on the National ECCE Curriculum Framework, which is to be implemented in all Anganwadi Centres.
- 7. The Annual curriculum and other related documents has also been approved by Early Childhood Care and Education Cell, Ministry of Women and Child Development and National Institute of Public Co-operation and Child Development (NIPCCD).
- 8. The Director, Integrated Child Development Services Scheme has sent capacity building processes which are adopted by our State for effective and timely implementation of the Annual Curriculum with the potential role of various stakeholders as per the ECCE Training norms of Ministry of Women and Child Development, Government of India which is furnished in Annexure IV.
- 9. Hence, the Director, Integrated Child Development Services Scheme has sent the following proposal to the approved batches by Government of India regarding Early Childhood Care and Education Training for the year 2015-2016, accommodating with the available unspent balance fund (including 40% State share) for sanction and approval.

i. Level-1

Training to untrained Anganwadi Workers for Early Childhood Care and Education at Sector Level (Phase-I).

ii. Level-2

- State Level Training of Trainers to District Level Master Trainers on Revised / validated Annual Curriculum for Early Childhood Care and Education (Phase-II)
- District Level Training of Trainers to untrained Child Development Project Officers / Supervisors on Revised / Validated Annual Curriculum for ECCE (Phase-I)

- 10. After careful examination, Government issues the following sanction and permission orders in the sharing pattern of 60:40 between Government of India and State:-
 - The Director, Integrated Child Development Services Scheme is permitted to impart Level-1 Training to untrained Anganwadi Workers for Early Childhood Care and Education Training (Phase-I) for remaining batches at the respective Projects.

- ii. Sanction is accorded for a sum of ₹78.88 lakh (Rupees seventy eight lakh and eighty eight thousand only) as per the details furnished in the Annexure-I to conduct Level-1 Training to untrained Anganwadi Workers for Early Childhood Care and Education at Sector Level (4640 Trainees) in 116 batches.
- iii. Permission is accorded to impart Level-2 State Level Training of Trainers to District Level Master Trainers (Phase-II) at State Training Institute, Chennai-113.
- iv. Sanction is accorded for a sum of ₹2.99 lakh (Rupees two lakh and ninety nine thousand only) as per the details furnished in the Annexure-II to conduct Level-2 State Level ToT to District Level Master Trainers on Revised / Validated Annual Curriculum for Early Childhood Care and Education (Phase-II) (140 Trainees) in 7 batches.
- v. Permission is accorded for Level-2 District Level ToT to untrained Child Development Project Officers / Supervisors (Phase-I) at Districts / Projects.
- vi. Sanction is accorded for a sum of ₹9.78 lakh (Rupees Nine lakh and seventy eight thousand only) as per the details furnished in the Annexure-III to conduct Level-2 District Level ToT to untrained Child Development Project Officers / Supervisors on Revised / Validated Annual Curriculum for Early Childhood Care and Education (Phase-I) (480 Trainees) in 24 batches.
- vii. The Director cum Mission Director is authorized to draw the amount in advance and incur the expenditure as indicated in the Annexure-II under Article-99 of Tamil Nadu Financial Code Volume-I.
- viii. The concerned District Programme Officers are authorized to draw the amount in advance and incur the expenditure as indicated in the Annexure I & III under Article-99 of Tamil Nadu Financial Code Volume-I subject to the following conditions.
 - a. The District Programme Officers are directed to render relevant statement of accounts and reports to the Director cum Mission Director, ICDS as soon as the training programmes are over, so as to enable the Director cum Mission Director, ICDS to report to the Government of India.
 - b. The District Programme Officers are directed to adjust the advance drawn under Article-99 of Tamil Nadu Financial code Volume-I at the Treasury / Pay and Accounts Office concerned soon after the Training Programmes are completed and within the time stipulated for advance drawn so as to avoid any audit objection.
 - c. The Pay and Accounts Officer/Treasury Officer concerned are advised to honour the bill as and when presented by the District Programme Officers concerned if otherwise found in order.

i. Pattern of the ECCE training

- The training package included two phases with a gap of around 4-6 months. The Phase-I training will comprise of 5 days training to District Level Master Trainers and 6 days training for Anganwadi Workers on curriculum roll out and implementation. This will be followed by field implementation of the curriculum by the Anganwadi Workers with the Supervisors and Child Development Project Officers providing on site mentoring and support.
- ➤ The Phase-II of the training programme will be held after duration of 4-5 months with a focus on experience sharing, challenges in implementation and seeking solutions for the same. Five days training will be held for District Level Master Trainers while three days training will be held for Anganwadi Workers.
- The phase-III training will be held for Anganwadi Workers alone for three days in the second year.

ii. Levels of ECCE Training

Each training phase is to be conducted in a cascade model at three levels, first by the experts to SLMTs, second by the State Level Master Trainers (SLMTs) to DLMTs and the third level to Anganwadi Workers by the District Level Master Trainers (DLMTs). The experts comprised of National Institute of Public Co-operation and Child Development (NIPCCD) Regional Centre faculty, external experts from Non-Governmental Organization and Academia etc. The State Level Master Trainers were ICDS functionaries and experts from the States who have extensively worked in ICDS and contributed to prepare the curriculum in the States. The District Level Master Trainers comprised of people from Middle Level Training Centres, Anganwadi Training Centres and Supervisors etc. who had extensive experience in ICDS.

iii. Cost norms and Budget for Training at different levels

All costs of training for Anganwadi Workers, District Level Master Trainers, Child Development Project Officers and Supervisors are booked under ICDS training budgets with 60:40 cost sharing ratio pattern between Government of India and State Government.

PHASE-II OF ECCE TRAINING

Meanwhile, the Regional National Institute of Public Co-operation and Child Development (NIPCCD) Training Centre, Bengaluru has completed Phase-II Early Childhood Care and Education Training to State Level Master Trainers of Tamil Nadu, ICDS along with other six Southern States, with more elaborate sessions on Assessment of children, monitoring and other implementation issues about Early Childhood Care and Education in the field. During that training, as well as in other meetings/workshops held at New Delhi, Government of India officials had insisted that any of the unspent balance of the Government of India fund available with State Government can be utilized for the subsequent training programme without getting revalidation from Government of India.
