ORDER:

A Scheme of awards for Anganwadi Workers has been constituted by the Government of India in two categories, one at the State level and another at the National level. The awards for Anganwadi Workers at the State level, carry a cash award of ₹5,000 each with a Citation. The awardees for the National level carry a cash award of ₹25,000 each with a Citation.

- 2. As per the guidelines of the Government of India, these awards have to be granted to the Anganwadi Workers selected from the nominations by a Selection Committee.
- 3. In the Government Order 1st read above, Government have sanctioned a sum of ₹4.90 lakh towards the State Level Awards to 98 Anganwadi Workers for the year 2016-2017.
- 4. In the letters 2nd read above, Government of India have modified the existing sharing ratio for all components of Integrated Child Development Services Scheme, except Supplementary Nutrition (SNP), as 60:40 between Centre and States. Cost sharing ratio for Supplementary Nutrition Programme will remain unchanged/same at 50:50.

- 5. In the letters 3rd read above, Government of India have requested the States to select 98 Anganwadi Workers towards the State Level Award and to recommend 6 Anganwadi Workers for selecting 2 Anganwadi Workers for National Level Award for the year of 2016-2017.
- 6. As per the Guidelines of Government of India, the Selection Committee meeting convened on 11.05.2017 consisting of the following officials for the selection of Anganwadi Workers for State Level Awards and recommending the Anganwadi Workers for National Level Awards.

 The Secretary to Government, Social - Chairman Welfare and Nutritious Meal Programme Department.

The Secretary to Government, Health and - Member Family Welfare Department.

3. The Director, Integrated Child Development - Member Services Scheme - Secretary

- 7. Accordingly, the Committee has selected 98 Anganwadi Workers for the year 2016-2017 and recommended 6 Anganwadi Workers for nomination of National Level Award for the year 2016-2017 which has also been sent to Government of India.
- 8. The expenditure of ₹4.90 lakh relating to State Level Award for 98 Anganwadi Workers shall be borne by the State Government from the funds released by Government of India under Integrated Child Development Services Scheme as per Government of India Guidelines.
- 9. In the letters 4th read above, Government of India have released a sum of ₹140.00 crore as Grants-in-aid to Tamilnadu under General Integrated Child Development Services Scheme for the year 2017-2018.
- 10. In the letter 5th read above, the Director, Integrated Child Development Services Scheme has sent proposal stating that the name of 6 Anganwadi Workers have been recommended by the Selection Committee for National Level Award which has already been sent to Government of India and requested the Government to accord sanction a sum of ₹4,90,000 towards the distribution of ₹5,000 as Cash Awards for State Level Award to 98 Anganwadi Workers for the year 2016-2017 in the sharing pattern of 60:40 (i.e., Government of India share ₹2,94,000, State share ₹1,96,000). Further, the Director, Integrated Child Development Services Scheme has also requested to permit him to authorize the District Programme Officers, Integrated Child Development Services Scheme concerned to draw the amount in respect of their Districts in advance under Article 99 of Tamil Nadu Financial Code Volume I to incur the expenditure.
- 11. The Government after careful examination, approve the list of 98 Anganwadi Workers selected for State Level Award recommended by the Selection Committee under Integrated Child Development Services Scheme for the year 2016-2017 as indicated in the Annexure to this order as per the Guidelines of Government of India and sanction is also accorded for incurring the expenditure of ₹4,90,000

(Rupees Four lakh and ninety thousand only) at the rate of ₹5,000 per Anganwadi Worker under the funds released by Government of India in the newly modified sharing pattern of 60:40 (Government of India share ₹2,94,000+ State share ₹1,96,000).

12. The expenditure sanctioned in para 11 shall be debited under the following head of account:

2236-Nutrition-02-Distribution of Nutritious Food and Beverages-101-Special Nutrition Programmes-Central Sector Schemes -SF-Integrated Child Development Services Scheme – Phase III - 59. Prizes and Awards (DPC.2236-02-101-SF-5905)

- 13. The Director, Integrated Child Development Services Scheme is permitted to authorise the District Programme Officers concerned to draw and incur the amount in respect of their Districts as per the number of Anganwadi Workers indicated in the Annexure to this order. The District Programme Officers are also directed to render relevant statement of accounts and reports to the Director, Integrated Child Development Services Scheme as soon as the activity is completed.
- 14. The Director, Integrated Child Development Services Scheme is requested to send the prize / award distribution report to the Government without fail.
- 15. This order issues with the concurrence of Finance (SW) Department vide its U.O.No.3879/Fin(SW)/2017, Dated 24.09.2017.
