Sub: Social Welfare and Nutritious Meal Programme Department – Integrated Child Development Services Scheme – Mobile Anganwadi services for migrant population from the funds of Tamilnadu Construction Workers Welfare Board of Labour and Employment Department at the cost of ₹40.85 lakh – implementation in convergence with the announcement made by the Hon'ble Chief Minister under rule 110 which is being implemented through Labour and Employment Department – Instructions – Issued.

In the Government Order first read above, orders have been issued as per the announcement made by Hon'ble Minister SW&NMP on the Floor of Legislative Assembly on 15.07.2014 for the provision of Mobile Anganwadi Services for the migrant population in the urban area of Chennai, Kancheepuram, Coimbatore, Tiruppur and Tiruvallur Districts at the cost of ₹40.85 lakh for the year 2014-2015 by utilizing the funds of Tamilnadu Construction Workers Welfare Board of Labour and Employment Department.

2. In the Government Order second read above, orders have been issued as per the Announcement made by the Hon'ble Chief Minister on the floor of Legislative Assembly on 12.08.2014 for the provision of Mobile Anganwadi Services in 50 places where the construction works are being carried out in large measure so as to ensure the services of Integrated Child Development Services Scheme for these workers by constructing 400 sq.foot measurement of temporary Anganwadi Centres with pre-fabricated materials by Public Works Department. For the benefit of average of 20 children, Supplementary Nutrition in the form of Weaning Food is

being provided for 6 to 36 months old children. Nutritious meal along with boiled egg thrice a week (Monday, Wednesday & Thursday), Black Bengal Gram/Green Gram on Tuesdays and Boiled Potato on Fridays are being provided for 2 to 5 years old children with pre-school education. Health Services such as referral, Vaccination, Vitamin A Tablets with health awareness to the children and Postnatal/Antenatal mothers are also being provided. Mother and Child Protection (MCP) Cards are issued to these children and mothers.

3. In the review meeting convened by the Principal Secretary, Social Welfare and Nutritious Meal Programme Department along with Secretary, Labour and Employment Department and Commissioner of Labour on 14.9.2015, it was deliberated that the announcement of Social Welfare and Nutritious Meal Programme Department towards the provision of Mobile Anganwadi Services may be implemented in convergence with the announcement towards the provision of Mobile Anganwadi Service made by the Hon'ble Chief Minister under rule 110 which is being implemented through Labour & Employment Department so as to avoid duplication and audit findings, if any.

4. In this connection, Government direct the Director, Integrated Child Development Services Scheme to implement the scheme of Mobile Anganwadi services for migrant population in the urban areas of Chennai, Kancheepuram, Coimbatore, Tirupur and Thiruvannamalai Districts at the cost of ₹ 40.85 lakh from the funds of Tamilnadu Construction Workers Welfare Board under Labour and Employment Department in convergence with the announcement made by the Hon'ble Chief Minister under rule 110 regarding the provision of Mobile Anganwadi services in 50 places where the construction works are being carried out in large measure which is being implemented through Labour & Employment Department so as to avoid duplication and audit findings. Further, the Director, Integrated Child Development Services Scheme is directed to coordinate with the Department of Labour and Employment /Commissioner of Labour /Tamilnadu Construction Workers Welfare Board in all aspects towards the effective implementation of scheme so as to ensure that the Integrated Child Development Scheme Services are provided to all eligible beneficiaries
