ORDER:-

In the letter 1st read above, Government of India have approved to hire 226 Vehicles for Integrated Child Development Services Scheme at the cost of ₹ 2.15 lakh per vehicle per annum and also instructed the States that Vehicles are to be used only in respect of the activities pertaining to the implementation of the Integrated Child Development Services Scheme. Vehicles are to be hired @ ₹ 2.15 lakh per vehicle per year and necessary expenditure in this regard may be incurred out of the funds released for implementation of the Integrated Child Development Services Scheme from time to time.

- 2. In the letter 2nd read above, Government of India have sanctioned additional allotment of 79 vehicles to Tamilnadu Integrated Child Development Services Scheme for hiring purpose. Hence, the approved vehicles to Tamilnadu State for hiring purpose are 305.
- 3. In the letter 3rd read above, Government of India have evolved Broad Frame Work to strengthen and restructure the Integrated Child Development Services Scheme in MISSON MODE and conveyed the revised sharing pattern of

various schemes under General Integrated Child Development Services Scheme. On the basis of revised sharing pattern, the scheme of hiring vehicle/Petrol, Oil and Lubricant has been revised from 90:10 to 75:25.

- 4. In Government Order 4th read above, Government have accorded sanction for a sum of ₹4,57,23,333 for hiring 319 vehicles during the year 2014-2015 from August 2014 to March 2015 in the sharing pattern of 75:25. Accordingly, the Director, Integrated Child Development Services Scheme has sent the Utilization Certificate stating that out of total sanctioned amount of ₹4,57,23,333, a sum of ₹3,03,70,612 was utilized for Hiring of Vehicles by the District Project Officers/Child Development Project Officers as on 31.3.2015 and the balance amount of ₹1,53,52,721 has been surrendered to the Government Account.
- 5. In the letters 5th read above, Government of India have released a sum of ₹51.31 crore as first and second instalments of grants in aid for the State of Tamilnadu towards the implementation of Integrated Child Development Services Scheme for the year 2015-2016 and credited into State Account on 28.05.2015 and 16.06.2015. The details of the vehicles approved by Government of India are as follows:-

6. In the letter 6th read above, the Director, Integrated Child Development Services Scheme has sent proposal as per the Annual Programme Implementation Programme to Government of India to accord sanction for a sum of ₹5,14,39,000 towards the hiring of 319 vehicles stating that in order to monitor the implementation of Integrated Child Development Services Scheme properly it is necessary to continue the scheme of hiring of vehicles to Integrated Child Development Services Scheme. Accordingly he has furnished the total requirement of funds towards the hiring of 319 vehicles for the year 2015-2016 from July 2015 to March 2016 as detailed below:-

- 7. Hence, the Director, Integrated Child Development Services Scheme has requested the Government to sanction a sum of ₹5,14,39,000 from July 2015 to March 2016 (75% Government of India share is ₹3,85,79,250 and 25% State Government share is ₹1,28,59,750) towards the hiring of 319 Vehicles for the usage of Integrated Child Development Services Projects and to permit him to draw and to disburse the amount to District Programme Officers/Child Development Projects Officers to hire 319 vehicles at the rate of ₹2.15 lakh/vehicle by following the conditions issued in para 6 (a to r) in the G.O.(Ms) No.39, Social Welfare and Nutritious Meal Programme Department, Dated 26.03.2012 and Government of India guidelines.
- 8. The Director, Integrated Child Development Services Scheme has also requested the Government to permit the District Programme Officers to fix the lowest rates selected from the 3 quotations of the Taxi owners which is equivalent or less than the rate fixed by the Regional Transport Officer of the respective area stating that the existing procedures by following the rates fixed by the Committee chaired by the District Collector in para 6(a) of the G.O. is more time consuming.
- 9. In G.O.(MS) No.39, Social Welfare and Nutritious Meal Programme Department Dated 26.3.2012, it has stated that the rates to be fixed based on the procedures prescribed and select the vehicle operator who quotes the least rates which may be placed before the Committee chaired by the District Collector constituted for this purpose.
 - 10. After careful examination, Government issues the following orders:-
 - (i) Government accord sanction for a sum of ₹4,57,23,333 (75% of Government of India share is ₹3,42,92,500 and 25% of State share is ₹1,14,30,833) towards the hiring of 319 vehicles for the usage of Integrated Child Development Services Scheme Projects for the year 2015-2016 from August 2015 to March 2016.
 - (ii) Government permit the Director, Integrated Child Development Services Scheme to hire 319 vehicles for the usage of Integrated Child Development Services Scheme Projects at the rate of ₹2.15 lakh per vehicle per annum
 - (iii) Government permit the Director, Integrated Child Development Services Scheme to draw and disburse the amount sanctioned in para 10(i) above to the District Programme Officers/Child Development Project Officers concerned to hire the vehicles.
 - (iv) The Director, Integrated Child Development Services Scheme is requested to follow the existing conditions scruplously issued in para 6(i) (a to r) of the G.O.(Ms) No.39, Social Welfare and Nutritious Meal Programme Department, Dated 26.3.2012 regarding hiring of vehicles and permitting the District Programme Officers to fix the least rates for hiring vehicles is not necessary.
 - (v) The Director, Integrated Child Development Services Scheme is requested to send necessary Utilization Certificate to the Government in time.
- 11. The expenditure sanctioned in the para 10 (i) above shall be debited under the following head of account.
