ORDER:-

In the Government Order first read above, detailed orders were issued on the Composition of Weaning food, procedures for procurement of weaning food, blend of critical processed materials, responsibilities of the Competent Enterprise, Technical qualifications required for selecting qualified Competent Enterprise, inviting and finalization of tenders etc..

2. In the letter second read above, Government of India have revised the Nutritional and Feeding Norms for Supplementary Nutrition in Integrated Child Development Services Scheme as follows:

3. In the Government order fourth read above orders have been issued in order to comply the direction in the judgment third read above, to ratify the action of the then Principal Secretary/Director, Integrated Child Development Services Scheme towards the implementation of revised Nutritional and Financial norms prescribed by Government of India and accord sanction for an additional amount of ₹61.35 crore over and above the BE for 2009-2010.

4. The nutritional Standards for different age groups/beneficiaries and the Cost norms for Supplementary Nutrition are as detailed below:

5. In the order sixth read above, Supreme Court of India has dismissed the W.P. 196/2001 in view of the passage of National Food Security Act, 2013, stated that nothing further survives in the petition. The Government of India notification under Supplementary Nutrition (under ICDS Scheme) Rules, 2017 to ICDS

beneficiaries has also been issued. Hence, the shortfall in nutrition being provided to ICDS beneficiaries in Tamilnadu compared to Nutritional norms prescribed by Government of India has to be filled in order to comply with the Nutritional norms prescribed by Government of India, mandated under National Food Security Act, 2013.

- 6. In the letters seventh read above, Government of India have approved Annual Programme Implementation Plan 2017-2018 with ₹ 573.02 crore as allocation for Supplementary Nutrition programme and ₹ 286.5121 crore as central share towards 50% and released a sum of ₹ 127.68 crore which has been credited into the Government Account.
- 7. In the letters eighth read above, the Director, Integrated Child Development Services Scheme has sent proposal in accordance with the National Food Security Act, 2013, to enhance the quantity of Supplementary Nutrition to the Integrated Child Development Services Scheme beneficiaries so as to match the norms specified in Schedule II of National Food Security Act, 2013 and Supplementary Nutrition (under ICDS Scheme) Rules, 2017, as detailed below:

8. At present around 75% requirement of weaning food under ICDS is procured from 25 Weaning food Manufacturing Women Co-operative Societies and balance from 2 private manufacturers selected as per Tamilnadu Transparency in Tenders Act, 1998 and Rules, 2000. Hence, the revised additional quantity of Supplementary Nutrition to be provided under ICDS and the additional cost for procuring Complementary weaning food for 6 months from October 2017 to March 2018 will be around ₹63.26 crore as detailed below:

- 9. Hence, the Director, Integrated Child Development Services Scheme has requested the Government to issue orders for enhancing the quantity of Supplementary Nutrition/ Complementary weaning food being provided and sanction of additional funds to the tune of ₹63.26 crore under Integrated Child Development Services Scheme.
 - 10. After careful examination, Government issue the following orders:
 - i. the Director, Integrated Child Development Services Scheme is permitted to enhance the quantity of Supplementary Nutrition/ Weaning Food to be provided to the Integrated Child Development Services Scheme beneficiaries as detailed in para 7 (C) & (D) above in order to achieve the nutrition norms prescribed by Government of India and mandated under National Food Security Act, 2013 and Supplementary Nutrition (under ICDS Scheme) Rules, 2017 with the existing composition itself at the first instance for six months from October 2017 March 2018.
 - ii. Additional Sanction is accorded for a sum of ₹63.26 crore (Sixty three crore twenty six lakh only) towards enhancing the quantity of Supplementary Nutrition / Weaning Food for six months from October 2017 March 2018.
 - iii. The Director, Integrated Child Development Services Scheme is permitted to procure and provide the additional quantity of supplementary nutrition in the form of weaning food detailed in para 7 (C) & (D) above as mandatory so as to achieve the nutritional norms envisaged in NFSA Act, 2013 until further orders in accordance with the existing tender procedures.
 - iv. the Director Integrated Child Development Services Scheme is requested to obtain the 50% share of additional funds sanctioned from Government of India without fail.
 - v. The Director, Integrated Child Development Services Scheme is directed to explore the possibilities regarding the provision of fortified milk to the children below 2 years and increasing the quantity of eggs to the children in the age group of 2 to 5 years and send necessary proposal to Government separately.
 - vi. The Director, Integrated Child Development Services Scheme is directed to include/submit the necessary additional funds for subsequent years directly to Finance Department.
 - vii. The Director, Integrated Child Development Services Scheme is directed to submit necessary Utilization Certificate to Government within time.
- 11. The expenditure sanctioned in para 10(ii) above shall be debited under the following Heads of Account:
