#### **Order:**

In Government Order fifth read above, orders have been issued, inter-alia, taking over of the existing "892 Functional Creches" which was run by the Tamil Nadu Social Welfare Board by the State Government on "as is where is basis" condition and released 60% of sanctioned Government of India's share of Rs.1,98,82,680/- to the "892 Functional Creches" under Rajiv Gandhi National Creche Scheme and the Director cum Mission Director, Integrated Child Development Services has been nominated as Nodal Officer for the implementation of Rajiv Gandhi National Creche Scheme(now National Creche Scheme) based on the Government of India's letter 2<sup>nd</sup> read above and subject to the conditions imposed by them and by the State Government.



2. The Hon'ble Delhi High Court vide in their order 4<sup>th</sup> read above has ordered in their order dated 23.05.2017 in W.P.No.11116/2015 among others alleging misappropriation of funds by Indian Council for Child Welfare that the creches would be required to make their claims for the period 01.04.2016 to 31.12.2016, in accordance with the scheme, by submitting the required documents to the respective State/UT Governments and the claim shall be made in the same manner and to the same authority as is being made post 01.01.2017. The procedure adopted by the respective State/UT Governments for verifying the functioning of the creches with effect from 01.01.2017 would also be adopted by them for also verifying the claims for the period 01.04.2016 to 31.12.2016. Since no grants were released by the Government of India based on the above Delhi High Court order for the period from 01.04.2016 to 31.12.2016 to Functional Creches run by Indian Council for Child Welfare, the Government of India have stated that and the grant be disbursed through the respective State/UT Governments after verification of the functioning of the creches and the claim made by the creches in the same manner as being followed by States/UTs for the period post 01.01.2017 for which separate action is being taken by the Government.

3. The Government of India, Ministry of Women and Child Development in their letter 2<sup>nd</sup> read above has conveyed the sanction to the payment of Rs.2,23,79,160/- to the State Government of Tamil Nadu as 4<sup>th</sup> quarter grant-in-aid (60% GOI's share) for the year 2016-2017 for running 1004 Creches (previously run through Tamil Nadu Social Welfare Board and Indian Council for Child Welfare) under National Creche Scheme for Children of Working Mothers. He has further stated that the fund sharing pattern amongst the Central Government, State Government and Organization/Institution running the Creches will be in the ratio 60:30:10 and sanction of funds is subject to the following conditions:-

- (i) The amount of the grant will have to be utilized for all components under the scheme as per the schematic norms.
- (ii) The State/UTs shall also be required to contribute their share for implementation of the National Creche Scheme.
- (iii) State Government shall conduct a survey to verify the existence and functioning of Creches and to release funds only to those Creches found functional as per their survey report. Unspent grants, if any, will be adjusted during the release of grants for the 1<sup>st</sup> quarter of 2017-2018.
- (iv) Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the Creches are registered in the NGO-PS portal and have furnished details of Unique ID from NGO-PS portal. Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.

4. The Honorary General Secretary, Indian Council for Child Welfare, Tamil Nadu in her letter 6<sup>th</sup> read above has furnished the list of Creches run by the Indian Council for Child Welfare (52 Creches) in Chennai and in the various Districts of Tamil Nadu and



also stated that they are finding it extremely difficult to run the Creches without the assistance of grants. Hence she has requested to sanction the funds for Functional Creches under the control of Indian Council for Child Welfare.

5. Based on the above Government of India sanction vide second read above, orders were issued in Government Order fifth read above, inter-alia for sanction of 60% of Government of India's share of Rs.1,98,82,680/- to the "892 Functional Creches" for the 4<sup>th</sup> quarter for the Financial Year 2016-2017 under National Creche Scheme previously run through Tamil Nadu Social Welfare Board as reported by him and the Director cum Mission Director, Integrated Child Development Services among other things has been appointed as Nodal Officer for the implementation of National Creche Scheme. In the meantime, based on the representation of the Honorary General Secretary, Indian Council for Child Welfare in her letter 6<sup>th</sup> read above, the Government has to release the Government of India sanction amount in respect of "52 Functional Creches" run by Indian Council for Child Welfare. The details of 52 creches are enclosed as annexure to this order.

6. The Government examined the representation of Indian Council for Child Welfare based on the direction of the Government of India and in continuation of Government Order fifth read above issue orders as follows:-

- (i) The Government of India in their sanction order vide 2<sup>nd</sup> read above have conveyed sanction for the 1004 creches including the 52 Functional Creches previously run under Indian Council for Child Welfare. Therefore, administrative sanction for Rs.17,38,620/- (Rupees Seventeen lakh thirty eight thousand six hundred and twenty only) and financial sanction for a sum of Rs.11,59,080/- (Rupees Eleven lakh fifty nine thousand and eighty only) as 60% of Government of India's share in respect of 52 Functional Creches is accorded and released for the year 2016-2017 as 4<sup>th</sup> quarter. The 30% balance share of State Government of Rs.5,79,540/- will be released separately.
- (ii) Government of India guidelines/NITI Aayog Instruction shall be followed scrupulously in this regard.
- (iii) The aforesaid creches shall be continued with the NGO's till 31.03.2018.
- (iv) The Director-cum-Mission Director, Integrated Child Development Services (ICDS) is nominated/authorized to draw and disburse the above grant to the 52 Functional Creches previously under Indian Council for Child Welfare and to take over the above creches on "as is where is basis" condition from Indian Council for Child Welfare.
- (v) The Director-cum-Mission Director, Integrated Child Development Services (ICDS) is directed to conduct evaluation study whether to continue with NGO's beyond 31.03.2018 or to be taken over by the Indian Council for Child Welfare etc., and to send a "overall consolidated evaluation report" for issue of detailed guidelines by the Government for continuous running of all the creches beyond 31.03.2018.



7. The Director-cum-Mission Director, Integrated Child Development Services is directed to take immediate action as ordered at para 7 above and to send compliance report immediately.

8. The amount sanctioned in para 6 shall be debited to the following head of Account

"2235-Social Security and Welfare. 02- Social Welfare – 102 Child Welfare – Scheme shared between State and Central – UD Assistance to creche under Rajiv Gandhi National Creche Scheme (RGNCs) 09-Grants in Aid 03-Grants for Spastic Scheme."

9. Necessary funds of Rs.11,59,080/- will be provided in RE/FMA 2017-2018. Pending provision of such funds, the Director cum Mission Director of Integrated Child Development Services is authorized to draw and disburse the amount sanctioned in para above. The Director cum Mission Director of Integrated Child Development Services shall include this items of expenditure while sending the proposal to Government in Finance (SW) Department, for inclusion in RE/FMA 2017-2018. However this expenditure shall be brought to the notice of Legislature by a specific inclusion in the Supplementary Estimates 2017-2018. The Director cum Mission Director of Integrated Child Development Services shall send necessary draft explanatory notes to Government in Finance(SW/BG.I) Department for inclusion of this expenditure in the Supplementary Estimates 2017-2018 at appropriate time without fail.

10. This order issues with the concurrence of Finance Department vide its U.O.No.49685/Fin(SW)/2017, dated 27.09.2017 and ASL No.1523(One thousand five hundred and twenty three)
