## ORDER:

In the Government Order 1<sup>st</sup> read above, orders were issued to provide 2 sets of colour uniform to 3,61,536 Anganwadi Children in the age group of 2-5 years in the 10 Districts of Chennai, Vellore, Trichy, Theni, Dindigul, Villupuram, Nagapattinam, Ariyalur, Perambalur and Tirunelveli at the cost of ₹9,03,84,000 for the year 2014-2015 towards the continuous implementation of announcement made by the Hon'ble Chief Minister on the floor of the Assembly during 2012-2013.

2. In the letter 2<sup>nd</sup> read above, the Director, Integrated Child Development Services Scheme has sent proposal to accord sanction for a sum of ₹ 9,16,05,500 stating that the scheme of "Provision of two sets of colour dresses" to Anganwadi children was introduced during 2012-2013 under rule 110 of Tamil Nadu Legislative Rules on Pilot basis to motivate the parents to send their children to Anganwadi centers without any prejudice. Most of the children attending Preschool in Anganwadi centers are from economically backward families. Parents also wanted their children to wear uniform like school children which was provided by Government at free of cost. This scheme is being implemented in 10 Districts covering 3,66,422 beneficiaries during the year 2015-2016. He has furnished the district wise budget details as follows:-

3. The Director, Integrated Child Development Services Scheme has furnished the total expenditure towards providing two sets of colour uniform to Anganwadi children in selected ten districts as detailed below and requested the Government to issue necessary orders:-

- 4. After careful examination Government issues the following orders:-
- i. to accord sanction for a sum of ₹9,16,05,500 (Rupees Nine crore sixteen lakh five thousand and five hundred only) towards the procurement and supply of uniform to 3,66,422 Anganwadi children in the age group of 2-5 years at Chennai, Vellore, Trichy, Theni, Dindigul, Villupuram, Nagapattinam, Ariyalur, Perambalur and Tirunelveli Districts during the year 2015-2016.
- ii. the Director, Integrated Child Development Services Scheme shall authorise the District Programme Officers / Child Development Project Officers concerned to procure and supply the stitched ready made colour uniform dresses as per the beneficiaries allotted to their Districts following Tamilnadu Transparency in Tenders Act 1998 and Rules 2000.
- the Director, Integrated Child Development Services Scheme is permitted to authorise the District Programme Officers / Child Development Project Officers concerned to draw and disburse the

- amount as per their requirement to procure and supply stitched ready made Colour Uniforms dresses.
- iv. the Director, Integrated Child Development Services Scheme is permitted to make inter- district transfer of Colour uniforms dresses / funds based on the actual requirement (no. of beneficiaries), if required, as the beneficiaries may vary, within overall financial allocation.
- v. the Director, Integrated Child Development Services Scheme shall send necessary utilization certificate to Government within time.
- 5. The above expenditure shall be debited under the following head of account:-
