In the Government Order 1<sup>st</sup> read above, orders have been issued towards the implementation of the scheme "Improving School preparedness and Child Health outcomes" through Integrated Child Development Services Scheme at the total cost of ₹ 956.57 lakh under TANII. A sum of ₹ 542.00 lakh has been allocated to M/s J-PAL and ₹ 414.57 lakh has been allocated to Integrated Child Development Services Scheme as intervention cost.

2. The Director, Integrated Child Development Services Scheme has sent proposal towards the implementation of the approved scheme "Improving School preparedness and Child Health outcomes" and requested the Government to permit him to draw and disburse the funds of ₹ 282.05 lakh allocated in the R.B.E. 2016-2017 by re-appropriation of the funds under relevant Heads of Accounts.

3. After careful examination, Government permit the Director, Integrated Child Development Services Scheme to incur the expenditure of ₹218.57 lakh (Rupees two crore eighteen lakh and fifty seven thousand only) towards the implementation of the approved scheme "Improving School preparedness and Child Health outcomes" through ICDS.
