### ORDER:

In the Government Order 1<sup>st</sup> read above sanction was accorded for a sum of Rs.264.97 lakh for conducting Vocational Training Programme for Adolescent Girls under Kishori Shakti Yojana in 23 districts at the level of first instalment of grants released by Government of India for implementing the Kishori Shakti Yojana Scheme for the year 2012-2013.

- 2. In the reference 2nd read above Government of India has released a sum of Rs.162.25 lakh as second instalment of grants-in-aid during 2012-2013 for implementation of Kishori Shakti Yojana.
- 3. In the reference 3<sup>rd</sup> read above the Principal Secretary/Special Commissioner, Integrated Child Development Services has sent the proposal for restricting amount of Rs.59.52 lakh towards the implementation of Kishori Shakti Yojana Scheme for the year 2012-2013 in 295 projects and 60 left out projects at the rate of Rs.4800/- per project for conducting melas/camps as detailed below:-

The Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme has also requested to permit and to authorize the District Programme Officers/Child Development Projects Officers to draw the amount as advance under Article 99 of Tamil Nadu Financial Code Volume I for conducting melas/camps in 295 projects and 60 left out projects covering 23 districts under Kishori Shakti Yojana Scheme for the year 2012-2013 and to inform the head office by giving Utilization Certificate.

- 4. The Government examined the proposal of the Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme, and accord sanction for a sum of Rs.59.52 lakh (Rupees Fifty nine lakh and fifty two thousand only) for conducting melas/camps under Kishori Shakti Yojana in 23 districts for the year 2012-2013 based on the second instalment of grants in aid released by Government of India.
- 5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:

2236-Nutrition-02-Distribution of Nutritious Food and Beverages-101-Special Nutrition Programmes- Schemes in the Twelfth Five year plan-III Centrally Sponsored-SI-Kishori Shakti Yojana – 72 Training (D.P.C.2236-02-101-SI-7201)

- 6. The Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme is permitted to authorize District Programme Officers/Child Development Projects Officers to draw the amount as advance under Article 99 of Tamil Nadu Financial code Volume I for conducting melas/camps and adjust the same after completion of the Programme with the Pay and Accounts Officer/Treasury Officer concerned and to send Utilisation Certificate to the Government.
- 7. The entire expenditure sanctioned in para 4 above shall be met by Government of India's 100% Centrally sponsored Scheme.

- 8. The Pay and Account Officer/Treasury Officers is directed to admit the bills as and when presented by the District Programme Officers / Child Development Projects Officers if it is otherwise found in order.
- 9. This order issues with the concurrence of Finance (SW) Department vide its U.O.No.96/DS(VS)/Finance(SW)/2013, Dated.16.03.2013.
