### ORDER:-

The Hon'ble Minister, Social Welfare and Nutritious Noon Meal Programme have made an announcement on the floor of Assembly while moving demand for grants of Social Welfare and Nutritious Programme for the year 2018-2019 as follows:-

“அங்கன்வாடி மையங்களுக்கு வருகை புரியும் குழந்தைகளுக்கு பாதுகாப்பான குடிநீர் வழங்குவதற்கும், மையங்களுக்கு தற்போது உள்ள தண்ணீர் வசதியை மேம்படுத்தவும் 1,132 மையங்களுக்கு, ₹ 1.13 கோடி செலவினம் மேற்கொள்ளப்படும்”

2. In the letter second read above, the Government of India have approved the provision of Drinking Water facilities to 566 Anganwadi Centres at ₹ 10,000 per centre

for the year 2017-2018 at the total cost of ₹ 56.60 lakh and released ₹ 33,96,000 as its 60% share.

3. In the letter third read above, the Government of India have approved the provision of Drinking Water facilities to further 566 Anganwadi Centres to the total cost of ₹ 56.60 lakh at ₹ 10,000 per centre in the sharing pattern of 60:40 between Centre Government and the State with effect from 01.12.2017 for the year 2018-2019.

4. In the letter fourth read above, the Government of India have requested to ensure that the Aspirational District are given priority for construction of Anganwadi Centre Building under convergence, provision of Toilets and Drinking Water facility, under Swachata Action Plan (SAP) in the Anganwadi Centre with the aim of saturating the districts and the work is completed within three months of release of Central share of grants for the purpose.

5. In the letter fifth read above, the Director cum Mission Director, Integrated Child Development Services has requested to sanction a sum of ₹ 1,13,20,000 with the sharing pattern of 60:40 (Centre Government share ₹ 67,92,000 + State Government share ₹ 45,28,000) @ ₹ 10,000 per Anganwadi Centre for provision of Drinking Water facility to 1,132 Anganwadi Centres functioning in own building (not having water facility within the centre) in 32 Districts subject to the Guidelines of Government of India and the following works has to be carried out under the provision of Drinking Water Facilities:-

Sl. No	Details of Works
1	Provision of one Number 500 litre Sintex Tank and construction of platform to place the tank (Not exceeding ₹ 5,000)
2	Provision of 4 Nos. Water Taps (Metal) (each one for Urinals, Toilet, Kitchen and outside the Anganwadi Centre) including cost of PVC pipes, PVC solution, other related fitting items and labour charges etc., (Not exceeding ₹ 5,000)

6. After careful examination, Government hereby issue the following orders:-

- i. Sanction is accorded for a sum of ₹ 1,13,20,000 (Rupees One crore thirteen lakh and twenty thousand only) with the sharing pattern of 60:40 (Government of India share of ₹ 67,92,000 + Government of Tamilnadu share of ₹ 45,28,000) for providing drinking water facility to 1,132 Anganwadi Centres at the rate of ₹ 10,000 per Anganwadi Centre as detailed in the annexure to this order to carry out following works and as per the guidelines of Government of India:-

Cost of 4 Nos. Water Taps (Metal) (each one for Urinals, Toilet, Kitchen and outside the Anganwadi Centre)	1,000
Cost of PVC pipes, PVC solution, other related fitting items including labour charges etc.,	4,000

- ii. The Director cum Mission Director, Integrated Child Development Services is directed to permit the District Project Officer/ Child Development Projects Officer to execute the work.
- iii. The Director cum Mission Director, Integrated Child Development Services Scheme is directed to send necessary utilisation certificate to Government within time.

7. The expenditure sanctioned in para 6(i) above shall be debitible under the following Head of Account:-

2236-Nutrition-02 Distribution of Nutritious food and Beverages -101  
Special Nutrition programmes – Schemes shared between State and Centre  
– UE – Strengthening and Restructuring of ICDS Scheme – 24 Matierials  
and Supplies. (DP code 2236 02 101 UE 2408).

8. Necessary additional funds of ₹1,13,20,000 will be provided in RE/FMA 2018-2019. Pending provision of such funds, the Director cum Mission Director, Integrated Child Development Services is authorized to draw and disburse the amount sanctioned in paragraph 6(i) above. The Director cum Mission Director, Integrated Child Development Services shall include this additional expenditure while sending the proposal to the Government in Finance (SW) Department, for inclusion in RE/FMA 2018-2019 without fail. However this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimates 2018-2019. The Director cum Mission Director, Integrated Child Development Services shall send necessary draft explanatory notes to Government in Finance (SW/BG-I) Department for inclusion in the Supplementary Estimates 2018-2019.

9. This order issues with the concurrence of Finance (SW) Department vide its U.O.No.55181/Fin(SW)/2018, Dated.31.10.2018 and with Additional Sanction Ledger No.1802 (One thousand eight hundred and two).
