ORDER:-

In Government Order first read above, sanction has been accorded for a sum of ₹ 1,17,12,000 in the sharing pattern 60:40 between Central Government and State Government at the rate of ₹ 12,000 per Anganwadi Centre towards the construction of baby friendly toilets to 976 Anganwadi Centres that are functioning in the Government buildings without having toilet facilities for the year 2017-2018.

2. In the letter second read above, the Government of India has approved a sum of ₹ 57,12,000 in the sharing pattern 60:40 between Central Government and State Government at the rate of ₹ 12,000 per Anganwadi Centre towards the construction of baby friendly toilets to 476 Anganwadi Centres that are functioning in the Government buildings without having toilet facilities for the year 2018-2019.

3. In the letter third read above, the Government of India has instructed to ensure that the aspirational districts is given over-riding priority for construction of Anganwadi Centres, provision of toilet and drinking water facility under Swachata Action Plan.

4. In the letter fourth read above, the Director cum Mission Director, Integrated Child Development Services has requested the Government to accord sanction to the tune of ₹ 57,12,000 in the sharing pattern of 60:40 between Central Government and State Government (₹ 34,27,200 being 60% of Central Government share and ₹ 22,84,800 being 40% of State Government share) towards the construction of baby friendly toilets to 476 Anganwadi Centres that are functioning in Government building without having toilets for the year 2018-2019.

5. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government issue the following orders subject to conditions that the Government of India's guidelines/schematic norms should be followed scrupulously:-

- i. Sanction is accorded for a sum of ₹ 57,12,000 in the sharing pattern of 60:40 between Central Government and State Government (₹ 34,27,200 being 60% of Central Government share and ₹ 22,84,800 being 40% of State Government share) towards the construction of baby friendly toilets to 476 Anganwadi Centres that are functioning in Government building without having toilets as detailed in Annexure to this order for the year 2018-2019.
- ii. The Director cum Mission Director, Integrated Child Development Services is permitted to draw the entire amount and credit the same to Savings Account maintained by Director of Rural Development and Panchayat Raj Department in the name of "State Employment Guarantee Fund" Tamil Nadu.
- iii. The Director cum Mission Director, Integrated Child Development Services is directed to furnish Utilization Certificate to Government within the stipulated time.

6. The expenditure sanctioned in para 5(i) above shall be debited under the following Head of Account:-

"4236 – Capital Outlay on Nutrition – 80 – General – 800 – Other Expenditure – Schemes Shared between State and Centre – UC Construction of Toilets to the Anganwadi Centres – 16 Major works. (DPC 4236 – 80 – 800 UC – 1609).
