ORDER:

The Hon'ble Minister for Social Welfare - Women Empowerment has made the following announcement while moving the demand for grant of this Department on the floor of the Tamil Nadu Legislative Assembly on 21.04.2022:-

2. In the letter second read above, the Director cum Mission Director, Integrated Child Development Services has stated that in order to address the low birth weight babies, when it is analysed in the field, it is found that IIT Madras supported solutions for handling the most important community health issue viz., "Grofi Smart infant growth scale" and this has a live artificial intelligence based dashboard to identify the field issues and address them immediately. The Grofi smart infant Growth scale covers Digital Weighing Machine, Digital Length Auto Measuring Sensor, Head Circumference with bar code reader.

3. The Director cum Mission Director, ICDS has therefore requested to permit to procure 1000 ICT based growth monitoring devices consisting with the following items to monitor the LBW babies in the 434 blocks and to support the parents by providing information education and nutrition to bring the new born to normal growth track at the earliest under POSHAN Abhiyaan at the cost of Rs.8500/- per device at a total cost of Rs.85,00,000/-(Rupees Eighty five lakhs only) in the sharing pattern of 80:20 between the Central Government and State Government by adopting Tamil Nadu Transparency in Tenders Act, 1998, Rules, 2000 / Government e Market portal:-

^{4.} After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services the Government accord sanction for a sum of Rs.85,00,000/- (Rupees Eight Five Lakh only) in the sharing pattern of 80:20 between the Central Government and State Government (80% of Central Government share being Rs.68,00,000/- 20% of State Government share being Rs.17,00,000/-) towards procurement of 1000 ICT based growth monitoring devices for the year 2022-2023 as detailed in paragraph-3 above under POSHAN Abhiyaan at an unit cost of Rs.8500/-per device by adopting Tamil Nadu Transparency in Tenders Act, 1998 and Rules, 2000 under Innovation funds of POSHAN Abhiyaan subject to the condition that the guidelines issued by the Government of India and schematic norms should be followed scrupulously.
