ORDER: -

In the letter second read above the Commissioner of Tourism has furnished a proposal received from the District Collector, Thoothukudi District for the construction of Interpretation Centre and Toilet Block at a cost of Rs.70.00 lakhs, at Sivan Kovil Road in Perungulam Town Panchayat at Thoothukudi District under State Plan Schemes. The Commissioner of Tourism has requested the Government to consider and approve the proposal sent by the District Collector, Thoothukudi for Construction of Interpretation Centre and Toilet Block at Sivan Kovil Road in Perungulam Town Panchayat in Thoothukudi District and sanction a sum of Rs.70.00 lakhs (Rupees Seventy Lakhs only), for this work as a special case.

2. The Government after careful consideration accept the proposal of the Commissioner of Tourism and issue the following orders: -

- i. Administrative and financial sanction is accorded to the Commissioner of Tourism for a sum of Rs.70.00 lakhs (Rupees Seventy lakhs only), for the construction of Interpretation Centre and Toilet Block at Sivan Kovil Road in Perungulam Town Panchayat in Thoothukudi District.
- ii. The Commissioner of Tourism is authorised to draw the amount sanctioned at item (i) above and permitted to disburse the same to District Collector, Thoothukudi and execute the works through the Executive Officer, Perungulam Town Panchayat, Thoothukudi District.

3. The amount sanctioned at para 2(i) above shall be debited under the following head of account:-

"5452 - Capital Outlay on Tourism – 01 - Tourist Infrastructure
101 - Tourist Centres – Schemes in the Twelfth Five
Year Plan – II State Plan – KV Improvement of basic facilities
in Tourist Centres-16 Major Works".

4. The Commissioner of Tourism shall ensure that necessary arrangements are made in the proposed works at Interpretation Centre and Toilet Block at Perungulam Town Panchayat, Thoothukudi District to visibly indicate that the above works were carried out through "State Tourism Department Funds"
