ORDER:-

The Hon'ble Minister for Tourism while moving the Demand for Grants for Tourism Department for the year 2021-2022, has made the following announcement in the Legislative Assembly:-

"The Mudaliyar Kuppam Boat House and the nearby Island area will be developed with additional facilities at an estimated cost of Rs.50.00 lakhs"

- 2. The Director of Tourism, in his letter read above has stated that a site inspection was conducted by the Principal Secretary to Government, Tourism, Culture & Religious Endowments Department and the Director of Tourism on 02.07.2021 and it was decided to propose eco-friendly interventions at the beach island to increase the tourist footfalls, enhance repeat visits and popularize this unique destination.
- 3. The Director of tourism has also stated that a project proposal is submitted at a cost of Rs.50.00 lakhs for the beachfront development at Mudaliarkuppam Boat House and it is stated that in Budget Estimate 2021-2022 a sum of Rs.5.00 crores has been allotted under the relevant head of account. He has further stated that the above proposal is prepared by Tamil Nadu Tourism Development Corporation and the project will be executed and maintained by Tamil Nadu Tourism Development Corporation Limited, Chennai.

- 4. The Director of Tourism has, therefore, requested that the Detailed Project Report for beachfront development at Mudaliarkuppam Boat House may be considered for approval and sanction of funds for Rs.50.00 Lakhs and also issue necessary orders in this regard.
- 5. The Government after careful examination, have decided to accept the proposal of the Director of Tourism and accord sanction a sum of Rs.50.00 lakhs (Rupees fifty lakhs only) for implementing the following beachfront development works at Mudaliarkuppam Boat house, Chengalpattu District:-
