### **ORDER:-**

In the G.O. first read above, orders have been issued for permitting the Managing Director, Tamil Nadu Tourism Development Corporation to conduct the 46th India Tourist and Industrial Fair 2020 at Island Grounds, Chennai and administrative sanction was also issued for a sum of Rs.126.00 lakhs to meet the expenditure towards erection of pavilion by Government Departments in the above Fair.

2. In the letter 2<sup>nd</sup> read above, the Managing Director, Tamil Nadu Tourism Development Corporation has stated that during 2020-2021, they were unable to conduct the 47<sup>th</sup> India Tourist and Industrial Fair due to COVID-19 pandemic Government lockdown restrictions. Now, this year the Government has given relaxations and also permitted TTDC to conduct the "Diwali Crackers Market 2021" at Island Grounds, Chennai-600009 for 20 days by strictly following COVID-19 Standard Operating Procedures. He has further stated that it has been proposed to conduct the 47<sup>th</sup> India Tourist and Industrial Fair 2022 at Island Grounds, Chennai-600009 for 70 days by strictly following the COVID-19 SOP's and other safety measures.

3. The Managing Director, Tamil Nadu Tourism Development corporation has, therefore, requested the Government as follows:-

- A) To issue clearance to Tamil Nadu Tourism Development Corporation for conducting the 47<sup>th</sup> India Tourist and Industrial Fair 2022 at Island Grounds, Chennai-600009 for 70 days by strictly following COVID-19 SOPs / Health Protocols issued by the Government.
- B) To allot funds of Rs.132.30 Lakhs ( Rupees one crore and thirty two lakhs thirty thousand only) being 5% increase over the last year fair sanction, for various Government Departments for the erection of pavilions for the 47<sup>th</sup> India Tourist and Industrial Fair 2022 at Island Grounds, Chennai, as was done in previous years.

4. In the G.O third read above, among others, the Government have permitted to conduct the India Tourist and Industrial Fair, Island Grounds, Chennai from 4th week of December 2021 to March 2022 subject to the condition that the event permitted shall be organised in open air with minimal risk for people and the organisers shall ensure that the Standard Operating procedures for Covid-19 applicable during the time of event enforced scrupulously.

5. The Government, after careful examination, accept the above proposal of the Managing Director, Tamil Nadu Tourism Development Corporation and orders as follows:

- i. The Managing Director, Tamil Nadu Tourism Development Corporation is permitted to conduct the 47<sup>th</sup> India Tourist and Industrial Fair 2022 at Island Grounds, Chennai, for 70 days by strictly following COVID-19 Standard Operating Procedures/Health Protocols issued by the Government.
- ii. Administrative sanction is accorded for Rs.126.00 Lakhs (Rupees one crore and twenty six lakhs only) for various Government Departments for the erection of pavilions for the 47<sup>th</sup> India Tourist and Industrial Fair 2022 at Island Grounds, Chennai as was done in previous years as follows:-

6. The above permission is granted subject to the following conditions:-

i. The organisers shall ensure that the Standard Operating procedures for Covid-19 applicable during the time of event enforced scrupulously.

ii. The Micro Small and Medium Enterprises Department shall erect a separate stall in the above Fair.

iii. The administrative Departments participating in the above Fair shall restrict their expenditure within the overall amount, for which administrative sanction accorded against their Department mentioned at para 5 (ii) above.

iv. The Director of Tourism / Managing Director, Tamil Nadu Tourism Development Corporation shall furnish the details on the ticket collections during the Trade Fair, remittance into Government account, collection of rent, if any from the exhibiting Departments etc., separately to Government for study.

v. This expenditure shall be incurred within the funds allocated to the Government Department concerned, during the financial year 2021-2022.

vi. Permission is granted to install combined stalls by the inter-related Departments, by joining together instead of going for separate stall for each and every Department.

vii. The following administrative Departments in Government shall issue financial sanction for the amount, as mentioned in para 5 (ii) above, of this order, in anticipation of the receipt of necessary proposal from their Head of Departments.

- x. Government will not entertain proposals from the Government Departments or Districts, for ratification of additional expenditure incurred over and above the amount mentioned in para 5 (ii) above, of this order.


