ORDER:

In the Government order first read above, orders have been issued permitting the Managing Director, Tamil Nadu Tourism Development Corporation, to conduct the 40th India Tourist and Industrial Fair 2014, at the Island Grounds, Chennai, during the 3rd week of December 2013, for the year 2013-14 and administrative sanction for Rs.75.00 lakhs towards the participation of Government Departments, in the above Trade Fair, at Island Grounds, Chennai.

- 2. In the letter 2nd read above, the Additional Chief Secretary / Managing Director, Tamil Nadu Tourism Development Corporation has furnished a proposal to the Government to permit Tamil Nadu Tourism Development Corporation to conduct 41st India Tourist and Industrial Fair 2015 at Island Grounds, Chennai, for the year 2014-15 during 3rd week of December 2014. He has also stated that the Government have allotted funds of Rs.75.00 lakhs for the 40th India Tourist and Industrial Fair 2014 and the cost of erection of pavilions has gone up steeply, due to increase in cost of materials and labour, and the funds allotted is insufficient. Hence he has therefore requested that the allotment of funds to various Government Departments to participate in the 41st India Tourist and Industrial Fair 2015 may be increased to Rs.1.05 crore during current year 2014-2015 (includes Rs.5.00 lakhs for Vigilance and Anti Corruption Department).
- 3. The Government after careful consideration accept the proposal of the Additional Chief Secretary / Managing Director, Tamil Nadu Tourism Development Corporation and issue orders as follows:
 - i. The Commissioner/Managing Director, Tamil Nadu Tourism Development Corporation is permitted to conduct the 41st India Tourist and Industrial Fair 2015, at the Island Grounds, Chennai, during the 3rd week of December 2014, for the year 2014-15.

ii. Administrative sanction is accorded for allotment of a sum of Rs.86.50 lakhs (Rupees eighty six lakhs fifty thousand only) for various Government Departments for erection of their pavilion for the year 2014-15, in the 41st India Tourist and Industrial Fair 2015, as follows:

- iii. The Departments participating in the above event shall ensure that the balance amount arising out of the above sanction, if any, have to be surrendered to the appropriate Government Account by the respective Departments.
- iv. The Commissioner/ Managing Director, Tamil Nadu Tourism Development Corporation shall furnish the details on the ticket collections during the Trade Fair, remittance into Government account, collection of rent, if any, from the exhibiting departments etc., separately, to Government for study.
 - 4. The above permission is granted subject to the following conditions:-
- i. This expenditure shall be incurred within the funds allocated to the concerned Government Department, during the present financial year 2014-2015.
- ii. Permission is granted to install combined stalls by the inter-related Departments, by joining together instead of going for separate stall for each and every Department.
- iii. All the Departments should restrict and incur the expenditure mentioned against them.
- iv. Tamil Nadu Tourism Development Corporation need not collect the 20% Advance Charges towards the Electricity Consumption, for the 41st India Tourist and Industrial Fair, prior to the inauguration of the Trade Fair, since Tamil Nadu Tourism Development Corporation is having sufficient funds.
- v. All the administrative Departments in the Secretariat shall issue financial sanction for the amount, as mentioned in para 3 of this order, in anticipation of the receipt of necessary proposal from their Head of Departments.
- vi. The Revenue Department in Secretariat shall issue financial sanction immediately, as mentioned in para 3 of this order, so as to install a combined stall, to the implementing agency, to be selected by that Department, as per the rules in force.
- vii. The stalls for Government Departments shall be completed prior to the inauguration of the Trade Fair, i.e. before 3rd week of December 2014.
- viii. Government will not entertain proposals from the Government Department or Districts, for ratification of additional expenditure incurred over and above the amount mentioned in para 3 of this order.
