ORDER:

In the Government Order first read above, orders have been issued for re-fixing the hire charges for hiring the Lorries of State Transport Undertakings to Government departments and Private parties.

- 2. In the letters second to ninth read above, the Managing Directors of all State Transport Undertakings have sent proposals to re-fix the hire charges for hiring the Lorries and Wreckers van / Crane of all State Transport Undertakings to Government departments and Private parties, since the operating cost have increased manifold and hire charges for lending lorry is still continuing without any revision even-though much later were fixed in the year 2008. Further, during the meeting of Chief Financial Officers of all State Transport Undertakings, it has been proposed to revise the rates for revision of hire charges for the Lorries and Wreckers van / Crane of all State Transport Undertakings while hiring to Government Departments / Private parties.
- 3. The Government, after careful examination, have decided to accept the revised rates as proposed by Chief Financial Officers of all State Transport Undertakings and hereby ordered to re-fix the following hire charges for the Lorry and Wrecker Van / Crane provided to Government Departments and Private parties with effect from the date of issue of this order.

The time shall be calculated in such a way that time taken from starting point of the vehicle from the depot upto 24 hours. If the vehicle operates in additional time, additional day hire charges shall be collected as detailed below:

From 1 hour upto 6 hours = 25% of the hire charges From 6 hours upto 8 hours = 50% of the hire charges

From 8 hours and above = one day hire charges

G.S.T. @ 5% or at the rates which are likely to be revised by Government of India from time to time shall be collected with all hire charges for the above Vehicles / Wrecker van / Crane / Lorry compulsorily.

Terms and conditions for lending the Wrecker van / Crane / Lorry

- The period of hire charges shall be reckoned between the time at which the Wrecker van / Crane leaves State Transport Undertakings premises and time at which it arrives back.
- If the Wrecker van / Crane is damaged during the recovery operation, the cost ii. of damage as may be determined by the Management will have to borne by the Government Department/partv.
- The Wrecker van / Crane will be sent only against an advance payment of iii. Rs.15,000/- per day.
- Government department and sister Corporation may be exempted from the iv. advance payments (Necessary requisition shall be obtained from competent authority)
- Only one skilled person will accompany the Wrecker van / Crane. Further, ٧. requirement if needed will have to be provided by the party.
- The rate for Wrecker van / Crane / Lorry to be increased by 10% every year vi. from first day of April of the next year.
