Announcement – 2018-2019 made by the Hon'ble Minister for Transport in the floor of Assembly during Budget session.

ORDER:-

While moving the Demand for Transport before the Tamil Nadu Legislative Assembly on 03.07.2018, the Hon'ble Minister for Transport, among other things, has made the following announcement:-

"தற்பொழுது பெரும்பாலான அரசுப் போக்குவரத்துக் கழகங்களின் அன்றாட அலுவலக நடைமுறைகள் அனைத்தும் மரபு வழியாக உள்ளது. குறிப்பாக, சென்னை போன்ற மாநகரங்களில் இயங்கிடும் கழகங்களின் பல உட்பிரிவு அலுவலகங்கள் கணினி வாயிலாக இணைக்கப்படிருந்தாலும், பல கழகங்கள் இன்றும் மரபு வழியிலே இயங்கி வருகின்றன.

அதனால் சில போக்குவரத்துக் கழகங்களில் பயன்படுத்தப்பட்டுவரும் மென்பொருள் பகுப்பாய்வு செய்யப்பட்டு, தேவைக்கேற்ப சில மாறுதல்களுடன் கூடிய புதிய மென்பொருள் உருவாக்கப்படும். பின்னா் அதன் மூலம் அனைத்து போக்குவரத்துக் கழகங்களின் அன்றாட அலுவலக நடைமுறைகள் அனைத்தும் ஒரு குடையின் கீழ், தமிழ்நாடு மின்னாளுமை முகமையின் ஆலோசனையுடன், இணையதள முறையில் ஒருங்கிணைக்கப்படும். "

- 2. In this regard, a meeting was convened with the officials of State Transport Undertakings / Tamil Nadu e-Governance Agency (TNeGA) and in the meeting it was decided that:
 - a) TNeGA may be entrusted with the entire consultancy for the project to bring in a web-based application and to guide the State Transport Undertakings in its implementation and that the TNeGA service charges required to be paid will be factored into the cost of the project.
 - b) the Software as proposed by TNeGA can be arranged through the existing market products (pre-Built solution) or with the COTS (Commercial Off-The Shelf) products or through Tender basis or with products that have been developed for other Government related projects in the state or elsewhere.
 - c) as the IT application will lead to substantial re-engineering, wherever necessary revised procedures will be initiated.

IFHRMS application which will function as an off the shelf project with the minimum customization and will also enable that most HR related transaction are fully covered.

- 3. An IT committee shall be formed from the State Transport Undertakings to anchor the entire effort. They shall be chosen based on their IT related knowledge and their usefulness to the task at hand. To the extent possible, they should be currently involved in the IT related processes of the State Transport Undertakings and the department.
- 4. The TNeGA team along with the IT team shall be formed among the IT knowledge staff who are already involved in assessing the As Is process. It shall analyse the process currently being followed in all departments in the State Transport Undertakings and would also take on record all the legacy IT applications that are in place. The Committee shall also analyse the current processes and suggest reengineering where required. To the maximum extent the Software application shall be from COTS (Commercial Off The Shelf) products or products already available in other departments and also from the market. The Hardware sizing and quantity will be undertaken side by side to enable finalization of the project cost so as to access funds wherever available for the task.
- 5. The Government after careful consideration have decided to form a committee with TNeGA and IT oriented people from the State Transport Undertakings to implement the points mentioned at para 2 (a), (b), (c), 3 and 4.
 - 6. The TNeGA is nominated as Nodal Agency to implement the process.
