In Tamil Nadu Government Gazette Extraordinary No.83, dated 31.01.2022, an Act has been passed as follows:-

3. Notwithstanding anything contained in any State law for the time being in force, any organization may request the Commission, in such form as may be prescribed, to recruit candidates for appointment to posts in that organisation.

Provided that no such request shall be made in respect of the post of Driver and the posts classified as Group D in the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.

- 2. In the reference 4th cited, the Chairman's Office, Transport Department has requested to permit all State Transport Undertakings to fill up the vacant post of Assistant Manager (Accounts) through Tamil Nadu Public Service Commission.
- 3. The Government after careful examination on the request of the Chairman's Office, Transport Department, accordingly permit the Managing Directors of all State Transport Undertakings to furnish the vacancy details of

Assistant Manager (Accounts) to Tamil Nadu Public Service Commission to notify the recruitment of said posts. The State Transport Undertakings wise vacancy details are as follows:-
