ORDER:

The Hon'ble Minister for Transport on the floor of Assembly on 29.08.2016 has announced that "AMMA" Driver Training Centres will be started in the premises of Regional Government Automobile Workshops at Trichy, Madurai and Salem to impart refreshment training to the Drivers of the Government Departments and also for new recruits.

2. The Director of Motor Vehicles Maintenance Department has sent detailed proposal to Government for sanctioning of recurring expenditure, non-recurring expenditure and creation of new posts to the "AMMA" Driver Training Centres at Trichy, Madurai and Salem.

3. The Government after careful examination, accorded sanction for the establishment of "AMMA" Driver Training Centres at Trichy, Madurai and Salem in the premises of Regional Government Automobile Workshops of Motor Vehicles Maintenance Department for imparting refreshment Training to the Drivers of the Government Departments and also for new recruits.

4. The Government accord following recurring and non-recurring expenditure to the “Amma” Driver Training Centres at Trichy, Madurai and Salem.

(i) The Government accord sanction for creation of the following staff for a period of one year from the date of issue of order:-

- Rs.80/- per day per person towards Refreshment charges.
- Rs.200/- per session per course towards Training materials.

7. The expenditure of Rs.2,49,36,000/- sanctioned in Para-4 above is an item of "New Instrument of Service". The approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director, Motor Vehicles Maintenance Department, Chennai / The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai-5 is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Director, Motor Vehicles Maintenance Department, Chennai-42 / The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai-5 is also directed to send a draft explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2017-18 to Finance (BG-I) Department without fail.
