## **ORDER:**

In the Government Order first read above, Government have issued orders for continuance of the scheme for conducting Refresher Course to 160 Special Educators working in the Early Intervention Centres for children with Mental Retardation in 32 districts for the year 2015-16 and sanctioned a sum of Rs.4,82,000/-

2. In the letter second read above, the State Commissioner for the Differently Abled has sent proposals to Government for continuance of the above scheme in 31 districts (except Dharmapuri) for the year 2016-17 and requested to sanction an amount of Rs.4,74,125/- for implementation of the scheme.

3. The Government, after careful examination, has decided to accept the proposal of the State Commissioner for the Differently Abled Persons and accord permission for continuance of the scheme of conducting Refresher Course to 155 Special Educators working in the 31 Early Intervention Centres for children with Mentally Retardated during the year 2016-17 and accord sanction of Rs.4,74,125/- (Rupees Four lakhs seventy four thousand one hundred and twenty five only) as detailed in the annexure to this order. The State Commissioner for the Differently Abled

is permitted to draw and disburse this amount as an advance to the implementing Non Governmental Organisation for conducting the Refresher Course.

3(i) The expenditure should be accommodating within the budget provision.

3(ii) The State Commissioner for the Differently Abled has requested to take up evaluation of the training programme through the Director of Evaluation of Applied Research so as to continue the training programme during 2017-18.

4. This expenditure sanctioned at para 3 above shall be debited under the following head of account:-
