## **ORDER:**

In the Government Order first read above, orders were issued for the continuance of the scheme of Early Intervention centres for children with Hearing Impairment in 32 districts and for conducting Orientation Training Programme for Special Educators for the year 2014-2015 and sanctioned a sum of Rs.89,67,900/- .

2. In the letters second read above the State Commissioner for the Differently Abled has sent proposals to Government for continuance of the Scheme of Early Intervention Centres for infants and young differently abled children with hearing impairment in 30 districts for the year 2015-2016 and requested to sanction an amount of Rs.84,41,500/- for the scheme.

3. The Government, after careful examination, has decided to accept the proposal of the State Commissioner for the Differently Abled Persons and issue the following orders:-

- i. Permission is accorded to the State Commissioner for the Differently Abled to continue and implement the scheme of "Early Intervention Centres for infants and young differently abled children with hearing impairment through Non Governmental Organisations in 30 Districts and for conducting Orientation Training Programme for Special Educators for the year 2015-16, and also, sanction is accorded for a sum of Rs84,41,500/- (Rupees Eighty four lakhs forty one thousand and five hundred only) as detailed in the Annexure-A & Annexure-B to this order.

- ii. Permission is accorded to draw and disburse the amount as an advance to the Early Intervention Centres of the Non Governmental Organisations through the District Differently Abled Welfare Officers.
- iii. Permission is accorded to depute 10 Special Educators for the Diploma in Teaching Young Hearing impaired as in service Training Programme during 2015-16 and sanction an amount of Rs.54,000/- (Rupees Fifty four thousand only) for this purpose as detailed in Annexure-A to this order.
- iv. Permission is also accorded to conduct Orientation Training Programme to the Special Educators and for this purpose sanction is accorded for an amount of Rs.1,67,500/- (Rupees One lakh sixty seven thousand and five hundred only) as detailed in Annexure-B to this order. The sanction of total cost for the continuance of 30 Early Intervention Centres, DTYHI (in service Training) and orientation training programme is Rs.84,41,000/- (Rupees Eighty four lakhs and forty one thousand only)
- v. Permission is accorded to the State Commissioner for the Differently Abled to decide on the removal and selection of implementing Non Governmental Organisations, after observing due formalities and principles of natural justice in consultation with Government.

4. The expenditure sanctioned at para 3(i), 3(iii) and 3(iv) above shall be debited under the following Head of Account:-
