ORDER:

As per section 33(ii) of the Rights of Persons with Disabilities Act, 2016, the Government shall, constitute an expert committee with representation of persons with benchmark disabilities for identification of posts for reservation for the differently abled persons.

2. In the Government order first read above, Government have constituted an Expert Committee for identifying the posts suitable for the differently abled persons under Groups 'A' and 'B' posts to implement 3% reservation as per the Persons with Disabilities (Equal Opportunities, Protection of rights and Full Participation) Act, 1995.

3. In reference third read above State Commissioner for the Differently Abled has sent proposal to Government to constitute an Expert Committee for identifying suitable posts as stipulated in Section 33 under chapter VI of the Rights of Persons with Disabilities Act, 2016. He has also suggested certain members to the Expert Committee as they are representatives of persons with benchmark disabilities and experts in specific category of disability.

4. Based on the above proposal the Government after careful examination have decided to constitute an Expert Committee with the following members:-
