## **ORDER:**

In the Government Order first read above, orders were issued delegating powers to the Principal Secretary / State Commissioner for the Differently Abled to implement the following 4 Welfare Schemes of Differently Abled Persons with the condition that the expenditure should be incurred only within the budget provision of the respective Head of Account and permitted to send proposal to Government for sanction of funds if required for the additional beneficiaries identified subsequently in the month of September and February:-

- i. Maintenance Allowance to Mentally Retarded persons;
- ii. Maintenance Allowance to Severely Affected persons;
- iii. Maintenance Allowance to Persons affected with Muscular Dystrophy; and
- iv. Maintenance Allowance to Leprosy affected persons.

2. In the said Government Order, the Principal Secretary/State Commissioner for the Differently Abled has been permitted to disburse the allowance to the existing number of beneficiaries under the above four categories on a monthly basis under 'Core Banking System' through District Differently Abled Welfare Officers from 2013-14.

3. In Government order second read above, Government have sanctioned incurring an additional expenditure of Rs.9,66,000/- for the newly identified 161 beneficiaries for the year 2015-16 (ie), for four months from December 2015 to March 2016 waiting list under the scheme of providing maintenance allowance to the Persons Affected With Muscular Dystrophy.

4. In the letters third read above, State Commissioner for the Differently Abled has stated that in the Government Order second read above orders were issued for sanctioning for an incurring an additional expenditure for Rs.9,66,000/- for the newly identified 161 beneficiaries for the year 2015-16 (ie), for four months from December 2015 to March 2016 waiting list under the scheme of providing maintenance allowance to the Persons Affected With Muscular Dystrophy. Further, this amount has not been included in the FMA 2015-2016. Hence, this amount has not been distributed by the District Differently Abled Welfare Officers during the financial year 2015-2016. Therefore, he has requested to Government to sanction an additional amount of Rs.24,00,000/- and towards sanction of allowances to 161 beneficiaries for the period from June 2016 to March 2017 and permit the State Commissioner for the Differently Abled to incur the above inclusion in the RE 2016-17.

5. The Government after careful examination accept the proposal of State Commissioner for the Differently Abled and accord sanction for incurring an additional expenditure of Rs.24,00,000/- (Rupees Twenty four lakh only) for the newly identified 161 beneficiaries for the year 2016-17 (ie), for ten months from June 2016 to March 2017 waiting list under the scheme of providing maintenance allowance to the persons affected with Muscular Dystrophy.

6. Necessary funds are provided in RE 2016-17 under the head 2235-02-101-CM-09-Grants-in-Aids-03-Grants for specific schemes.

The expenditure sanctioned at para 5 above shall be debited under the following Head of Account:-

“2235- Social Security and Welfare-02. Social Welfare-101- Welfare of Differently Abled Persons- I- Non Plan-CM- Maintenance Grants to the Persons With Muscular Dystrophy Disease -09- Grants-in-aid 03 Grants for Specific Schemes.”
