ORDER:

In Government Order first read above, orders were issued for providing of Nutritious Meal and Weaning Food to the children with disabilities those who are attending the Early Intervention Centres below the age group of 5 years through Anganwadi Centres, functioning nearby to the Early Intervention Centre for the year 2013-14 and also, sanctioned a sum of Rs.46,64,109/- for the same.

2. The State Commissioner for the Differently Abled in his letter second read above has stated that the number of children benefited under the scheme during the year 2013-14 are 3047. The existing numbers of Early Intervention Centres are 83. Further, he has requested the Government to permit to continue the scheme of providing Noon Meal and Weaning Food to the Children with Disabilities in the Early Intervention Centres during the year 2014-2015 and to sanction a sum of Rs.4,15,000/- towards transport charges and to draw and disburse the amount as an advance to the implementing Non Governmental Organisations of Early Intervention Centres through District Differently Abled Welfare Officers.

3. The Government after careful examination of the proposal of the State Commissioner for the Differently Abled and accord sanction for a sum of Rs.4,15,000/- (Rupees Four lakhs and fifteen thousand only) towards transport charges for providing Noon Meal and Weaning food to the children with disabilities in the 68 Early Intervention

Centres functioning under the control of State Commissioner for the Differently Abled for the year 2014-15.

4. The amount sanctioned in para 3 shall be debited under the following head of accounts:-

“2235-Social Security and Welfare-02- Social Welfare-101-Welfare of Differently Abled Persons- Schemes in the Twelfth Five Year Plan-II State Plan- MW-Assistance to the Non Governmental Organisations for Early Intervention Centre for bringing the Food from Anganwadi Centre to Early Intervention Centre.”-73-Transport Charges.

5. The State Commissioner for the Differently Abled is permitted to draw and disburse the amount sanctioned in para 3 above as an advance to the implementing Non Governmental Organisations of Early Intervention Centres through District Differently Abled Welfare Officers for the year 2014-2015.
