### **ORDER:**

In the Government Order first read above, orders were issued that all orders issued by School Education Department governing teaching profession should also be made applicable to the personnel working in all the schools under the control of the Directorate of Social Welfare.

In the Government Order second read above, Department for Welfare of Differently Abled Persons was newly created by bifurcating from Social Welfare and Nutritious Meal Programme Department in Secretariat, subsequent to the above, in Government Order third read above, orders were issued by transferring the cadre controlling powers of all the personnel working under the control of Commissionerate for the Differently Abled from the Director of Social Welfare to the State Commissioner for the Differently Abled and further amendment has also been issued in the Government Order fourth read above in this regard.

3. In the letter fifth read above, the State Commissioner for Differently Abled has requested to issue orders to implement the benefits / concession to the 23 Special Schools and 54 Government Aided Special Schools functioning under the control of Commissionerate for the Welfare of Differently Abled as issued for the School Teachers under School Education Department from time to time.

4. The Government after careful examination of the proposal of State Commissioner for Differently Aabled, issue the amendment to G.O. (Ms.) No.820, Backward Class, Nutritious Meal Programme and Social Welfare Department, dated 23.09.1989 as follows :-

**AMENDMENT**

For the existing para 5, the following paragraph shall be substituted:-

“5. In the circumstances the Government direct that all orders issued by Education Department governing teaching profession shall also be made applicable to the personnel working in all schools under the control of the Directorate of Social Welfare and Commissionerate for the Differently Aabled.”
