ORDER:

In the Government Order first read above, orders were issued for continuance of Early Intervention Centres for infants and young differently abled children with hearing impairment through Non Governmental Organisations in 30 Districts and for conducting Orientation Training Programme for Special Educators for the year 2015-16, and also, sanctioned a sum of Rs.84,41,500/-.

2. In the letter second read above, the State Commissioner for the Differently Abled has stated that the District Differently Abled Welfare Officer has informed that by mistake they did not claim the amount sanctioned to District Differently Abled Welfare Officer, Tirunelveli towards Early Intervention Centre for Hearing Impaired children for the year 2015-2016 and requested the State Commissioner for the Differently Abled for sanction of funds Rs.2,74,000/- in the year 2016-17. Further, the State Commissioner for the Differently Abled has requested the Government to sanction a sum of Rs.2,74,000/- towards the Early Intervention Centre for Hearing Impairment children at Tirunelveli for the year 2015-16 as detailed below:-

The Government after careful examination has decided to accepted the proposal of State Commissioner for the Differently Abled to accord sanction for an amount of Rs.2,74,000/- (Rupees Two lakhs and seventy four thousand only) as detailed in Annexure in its order to, Early Intervention Centre for Children with Hearing Impaired at Tirunelveli District for the year 2015-16 and also permission is accord to draw and disburse the amount to Early Intervention Centre of the Non Governmental Organisation through the District Differently Abled Welfare Officer. Further, State Commissioner for the Differently Abled has requested to ensure the receipt of consolidated proposal from all the Districts and send a single proposal to Government in future.
- 4. The expenditure sanctioned at para 3 above shall be debited under the following Head of Account:-

- 5. Necessary additional funds of Rs.2,74,000/- have been provided in Revised Estimate 2016-17. The State Commissioner for the Differently Abled is authorized to draw and incur the expenditure sanctioned in para 3 above.
