ORDER:-

Section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (Central Act 18 of 2016) (as mandate by the Aadhaar and Other Laws (Amendment) Act, 2019) (Central Act 14 of 2019) provides as follows:-

"7. The Central Government or, as the case may be, the State Government may, for the purpose of establishing identity of an individual as a condition for receipt of a subsidy, benefit or service for which the expenditure is incurred from, or the receipt there from forms part of, the Consolidated Fund of India or the Consolidated Fund of State, require that such individual undergo authentication, or furnish proof of possession of Aadhaar number or in the case of an individual to whom no Aadhaar number has been assigned, such individual makes an application for enrolment:

Provided that if an Aadhaar number is not assigned to an individual, the individual shall be offered alternate and viable means of identification for delivery of the subsidy, benefit or service."

2. In the circular first read above, the UIDAI has issued Guidelines for use of Aadhaar under section 7 of the said Central Act 18 of 2016 by the State Government for the schemes funded out of Consolidated Fund of State and has also stated that, as per the provision in the Aadhaar and Other Laws (Amendment) Act, 2019, (Central Act 14 of 2019) the State Government can

henceforth, mandate use of Aadhaar Authentication for the beneficiaries under section 7 of the said Central Act 18 of 2016 for those schemes which are funded out of the Consolidated Fund of the State and to do so the departments under the State Government will need to issue notification under section 7 of the said Central Act 18 of 2016 in respect of specific schemes, similar to the ones published by the Central Ministries/Departments.

3. Accordingly, the Government direct that the appended Notification shall be published in the Tamil Nadu Government Gazette, Extraordinary for mandating use of Aadhaar Authentication by the beneficiaries under the Schemes implemented by Welfare of Differently Abled Persons Department as per the provisions of section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (Central Act 18 of 2016).

APPENDIX**NOTIFICATION-I**

WHEREAS, the use of Aadhaar as an identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enables beneficiaries to get their entitlements directly in a convenient and seamless manner by obviating the need to produce multiple documents to prove one's identity;

AND WHEREAS, the Welfare of Differently Abled Persons Department (hereinafter referred to as the Department), is administering the Welfare Schemes specified in the Schedule annexed to this Notification to the Differently Abled Persons residing in the State (hereinafter referred to as the Schemes), which is being implemented through the Commissionerate for Welfare of the Differently Abled (hereinafter referred to as the Implementing Agency);

AND WHEREAS, under the Schemes, the assistances as mentioned in the Schedule annexed to this notification is given to the Differently Abled Persons residing in the State (hereinafter referred to as the beneficiaries), by the implementing Agency as per the extent Scheme guidelines;

AND WHEREAS, the aforesaid Schemes involve recurring expenditure incurred from the Consolidated Fund of the State;

NOW, THEREFORE, in pursuance of section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (Central Act 18 of 2016) (hereinafter referred to as the said Act), the Government of Tamil Nadu hereby notifies the following, namely:-

1. (1) An individual eligible for receiving the benefits under any of the Scheme shall hereby be required to furnish proof of possession of the Aadhaar number or undergo Aadhaar authentication.
- (2) Any individual desirous of availing benefits under any of the Scheme, who does not possess the Aadhaar number or, has not yet enrolled for Aadhaar, shall be required to make application for Aadhaar enrolment before registering for the Scheme provided that he is entitled to

obtain Aadhaar as per section 3 of the said Act and such individuals shall visit any Aadhaar enrolment centre (list available at the Unique Identification Authority of India (UIDAI) website www.uidai.gov.in) to get enrolled for Aadhaar.

(3) As per regulation 12 of the Aadhaar (Enrolment and Update) Regulations, 2016, the Department through its Implementing Agency, is required to offer Aadhaar enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar enrolment centre located in the respective Block or Taluk or Tehsil, the Department through its Implementing Agency shall provide Aadhaar enrolment facilities at convenient locations in coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves:

Provided that till the time Aadhaar is assigned to the individual, benefits under, the Scheme shall be given to such individual, subject to the production of the following documents in original, namely:-

- (a) If he / she has enrolled, his / her Aadhaar Enrolment Identification Slip; and
- (b) any one of the following documents, namely:-
 - (i) Bank or Post Office Passbook with Photo; or
 - (ii) Permanent Account Number (PAN) Card; or
 - (iii) Passport; or
 - (iv) Ration Card; or
 - (v) Voter Identity Card; or
 - (vi) MGNREGA Card; or
 - (vii) Kisan Photo Passbook; or
 - (viii) Driving license issued by the Licensing Authority Under the Motor Vehicles Act, 1988 (Central Act 59 of 1988); or
 - (ix) Certificate of identity having photo of such person issued by a Gazetted Officer or a Tahsildar on an Official letter head; or
 - (x) Government Photo ID Card; or
 - (xi) Any other document specified by the State Government;

Provided further that the above documents may be checked by an officer specifically designated by the Department for that purpose.

2. In order to provide benefits to the beneficiaries under the Schemes conveniently, the Department through its Implementing Agency shall make all

the required arrangements to ensure that wide publicity through the media shall be given to the beneficiaries to make them aware of the said requirement.

3. In all cases, where Aadhaar authentication fails due to poor biometrics of the beneficiaries or due to any other reason, the following remedial mechanisms shall be adopted, namely;-

- (a) in case of poor finger-print quality, iris scan or face authentication facility shall be adopted for authentication. There by the Department through its implementing Agency shall make provisions for iris scanners or face authentications along with finger-print authentication for delivery of benefits in seamless manner;
- (b) in case the biometric authentication through fingerprints is not successful, wherever feasible and admissible, authentication by Aadhaar One Time Password or Time -Based One-Time Password with limited time validity, as the case may be, shall be offered;
- (c) in all other cases where biometric or Aadhaar One Time Password or Time-Based One-Time Password authentication is not possible, benefits under the Scheme may be given on the basis of physical Aadhaar letter whose authenticity can be verified through the Quick Response code printed on the Aadhaar Card in original and necessary arrangement of Quick Response Code reader shall be provided at the convenient locations by the Department through its Implementing Agency.

4. In addition to the above, in order to ensure that no bonafide beneficiary under the Schemes is deprived of his due benefits, the Department through its Implementing Agency shall follow the exception handling mechanism as outlined in the Office Memorandum of Direct Benefit Transfer Mission, Cabinet Secretariat, Government of India, dated the 19th December 2017.

5. This Notification shall come into effect from the date of its publication in the Tamil Nadu Government Gazette.

NOTIFICATION - II

WHEREAS, the use of Aadhaar as an identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enables beneficiaries to get their entitlements directly in a convenient and seamless manner by obviating the need to produce multiple documents to prove one's identity;

AND WHEREAS, the Welfare of Differently Abled Persons Departments is administering the Welfare Schemes specified in the Schedule annexed to this Notification to the Differently Abled Children residing in the State (hereinafter referred to as schemes), which is being implemented through the Commissionerate for Welfare of the Differently Abled (hereinafter referred to as the Implementing Agency);

AND WHEREAS, under the Schemes, the assistances as mentioned in the Schedule annexed to this notification is given to the Differently Abled Children residing in the State (hereinafter referred to as the beneficiaries), by the implementing Agency as per the extant Scheme guidelines;

AND WHEREAS, the aforesaid Schemes involve recurring expenditure incurred from the Consolidated fund of the State;

NOW, THEREFORE, in pursuance of section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (Central Act 18 of 2016) (hereinafter referred to as the said Act), the Government of Tamil Nadu hereby notifies the following, namely:-

1. (1) A child desirous of availing the benefit under any of the Scheme shall hereby be required to furnish proof of possession of the Aadhaar number or undergo Aadhaar authentication.
- (2) Any child desirous of availing the benefit under any of the Scheme, who does not possess the Aadhaar number or, has not yet enrolled for Aadhaar, shall be required to make application for Aadhaar enrolment subject to the consent of his parents or guardians, before registering for the Scheme

provided that he is entitled to obtain Aadhaar as per section 3 of the said Act and such children shall visit any Aadhaar enrolment centre (list available at the Unique Identification Authority of India (UIDAI) website www.uidai.gov.in) to get enrolled for Aadhaar.

- (3) As per regulation 12 of the Aadhaar (Enrolment and Update) Regulations, 2016, the Department through its implementing agency, is required to offer Aadhaar enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar enrolment centre located in the respective Block or Taluk or Tehsil, the Department through its implementing Agency shall provide Aadhaar enrolment facilities at convenient locations in coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves:
- (4) Provided that till the time Aadhaar is assigned to the child, the benefit under the Scheme shall be given to such children, subject to production of the following documents, namely:-
- (a) If the child has been enrolled after attaining the age of five years (with biometrics collection), his Aadhaar Enrolment identification slip, or of biometric update identification slip, and
 - (b) Any one of the following documents, namely:-
 - (i) Birth Certificate; or Record of Birth issued by the appropriate authority; or
 - (ii) School Identity Card, duly signed by the Principal of the school, containing parents names; and
 - (c) any one of the following documents as proof of relationship of the beneficiary with the parent or legal guardian as per the extant Scheme guidelines, namely:-

- (i) Birth certificate; or Record of Birth issued by the appropriate authority; or
- (ii) Ration Card; or
- (iii) Ex-Servicemen Contributory Health Scheme (ECHS) Card; or Employees, State insurance Corporation (ESIC) Card; or Central Government Health Scheme (CGHS) Card; or
- (iv) Pension Payment Order; or
- (v) Army Canteen Card; or
- (vi) Any Government Family Entitlement Card; or
- (vii) Any other document as may be specified by the Department:

Provided further that the above documents shall be checked by an officer specifically designated by the Department for that purpose.

2. In order to provide benefits to the beneficiaries under the Schemes conveniently, the Department through its Implementing Agency shall make all the required arrangements to ensure that wide publicity through media shall be given to the beneficiaries to make them aware of the said requirement.

3. In all cases, where Aadhaar authentication fails due to poor biometrics of the beneficiaries or due to any other reason, the following remedial mechanisms shall be adopted, namely:-

- (a) In case of poor fingerprint quality, iris scan or face authentication facility shall be adopted for authentication, thereby the Department through its Implementing Agency shall make provisions for iris scanners or face authentication along with finger-print authentication for delivery of benefits in seamless manner;
- (b) In case the biometric authentication through fingerprints or iris scan or face authentication is not successful, wherever feasible and admissible authentication by Aadhaar one Time password or Time-based One-Time Password with limited time validity, as the case may be, shall be offered;
- (c) In all other cases where biometric or Aadhaar one Time password (OTP) or Time-based one-time password

authentication is not possible, benefits under the Schemes may be given on the basis of physical Aadhaar letter whose authenticity can be verified through the Quick Response (QR) code printed on the Aadhaar letter and the necessary arrangement of QR code reader shall be provided at the convenient locations by the Department through its Implementing Agency.

4. Notwithstanding anything contained herein above, no child shall be denied benefit under the Schemes in case of failure to establish his identity by undergoing authentication, or furnishing proof of possession of Aadhaar number, or in the case of a child to whom no Aadhaar number has been assigned, producing an application for enrolment. The benefit shall be given to him by verifying his identity on the basis of other documents as mentioned in clauses (b) and (c) of the proviso to sub-paragraph (3) of paragraph 1, and where benefit is given on the basis of such other documents, a separate register shall be maintained to record the same, which shall be reviewed and audited periodically by the Department through its Implementing Agency.

5. This Notification shall come into effect from the date of its publication in the TamilNadu Government Gazette.
