

Welfare of Differently Abled Persons Department – Identification of suitable posts for Differently Abled Persons under Group A & B Categories as per section 33(i) of the Rights of Persons with Disabilities Act, 2016 – Orders - Issued.

ORDER:

As per section 33(i) of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016) "the appropriate Government shall identify posts in the establishments which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved in accordance with the provisions of section 34" of the said Act.

- 2. In the Government order second read above, 263 posts under group A & B category were identified as suitable for differently abled persons under 3% reservation. In the Government order third and fourth read above Government have constituted an Expert Committee for identifying Group 'A' and 'B' posts. In the Government order fifth read above Government have issued orders for increasing the percentage of reservation of differently abled persons in employment from 3% to 4%.
- 3. In the letter sixth read above, the Registrar General, High Court of Madras has requested to offer opinion regarding accommodating persons with disability to certain clauses mentioned in the G.O.(Ms) No.21, Welfare of Differently Abled Persons Department, dated 30.5.2017, in the cadre of Civil Judge and District Judge (entry level) with the percentage of disability which would be admissible. Moreover, the Hon'ble High Court of Madras in its interim order dated 07.08.2017 in W.P. No.13350 of 2017 in the

seventh read above has directed that the genuine grievances of the differently abled persons with regard to the suitability for different Group-A and Group-B posts shall be taken into consideration while issuing fresh orders under Section 34 of the Rights of Persons with Disabilities Act, 2016.

- 4. In the Letter eighth read above, based on the recommendations of the Expert Committee, the State Commissioner for the Differently Abled has sent proposal to Government for identification of posts suitable for Differently Abled Persons under Group 'A' and 'B' categories.
- 5. The Government after careful examination of the proposal of the State Commissioner for the Differently Abled, have identified the following posts as suitable for the differently abled persons:-

6. The Government also direct that 4% of the vacancies in direct recruitment for the identified posts in A and B groups, where the rule of reservation is applicable for the SCs / STs / BCs and other communities, shall be reserved for the differently abled persons. If only one post is available for recruitment in these categories, the usual procedure for recruitment will be followed. In so far as Executive Posts are concerned, the individual shall produce a certificate of physical fitness from the Medical Board to the effect that their disability will not affect the performance of the job to which he/she has been selected before appointment.
