ORDER:

In the letter second read above, the State Commissioner for Differently Abled has informed that during the recent floods in the State severe damage occurred in the District Differently Abled Welfare Offices of Tuticorin, Government Special Schools of Tiruvallur, Kancheepuram and in the Commissionerate for Welfare of Differently Abled. The entire east side compound wall in State Commissionerate was damaged, endangering the security. The two motors pumps and 3 computers and inverter in the ground floor was totally damaged. He has requested to sanction fund for a sum of Rs.76.35 lakhs for making repair and restoration of the infrastructure in the above places.

2. In the Government letter first read above, the State Commissioner for Differently Abled was requested to take appropriate action to include the additional funds of Rs.76.35 lakhs in the RE/FMA 2015-2016 under the respective head of account and incur the expenditure.

3. After careful examination, the Government have decided to accept the request of State Commissioner for Differently Abled and accord sanction for a sum of Rs.76.35 lakhs (Rupees seventy six lakhs and thirty five thousand only) towards repair and restoration of the infrastructure damaged during the recent flood in the Commissionerate for the Welfare of Differently Abled, Chennai-78, Government Higher Secondary School for the Blind, Poonamallee, District Differently Abled Welfare Office, Tuticorin and Government High School for the Hearing Impaired, Kancheepuram.
