## **ORDER:**

Thiru A. Rajendran, Keelpattu Village, Polur Taluk of Tiruvannamalai District has 4 children. Though they were born healthy, by the age of 4-5 they developed Muscular Dystrophy, resulting in weakness of the entire muscle system of the children. Out of the four children, one girl child passed away on 15.11.2014. Based on the petitioner's application for providing monthly disabled pension to his 3 children, a sum of Rs.1,500/- per child per month is being given to the family by Welfare of Differently Abled Persons Department. Since the above pension is not enough to look after the children and the family, Thiru Rajendran submitted a petition to the District Collector for financial assistance under Chief Minister's Public Relief Fund (CMPRF). The District Collector, Tiruvannamalai has considering the future of the children and acute poverty of the family, recommended financial assistance under CMPRF as a special case. The report was sent to Commissioner for Revenue Administration and in turn the same has been forwarded to State Commissioner for the Differently Abled for consideration.

2. In the meantime, the petitioner filed W.P.No.33172/2016 before the High Court of Madras and requested relief under Chief Minister's Public Relief Fund (CMPRF). The High Court in its order dated 26.09.2016 has disposed of the case with a direction to the Commissioner for Differently Abled Welfare to speed up the matter, obtain appropriate report and place the same before the Special Officer of Hon'ble Chief Minister's Special Cell.

3. The Special Officer, Chief Minister's Special Cell has requested the State Commissioner for the Differently Abled to send necessary report in this regard. In this connection, the State Commissioner for the Differently Abled has reported that

- i. A monthly maintenance grant of Rs.1,500/- per month for each child is being provided. Accordingly a sum of Rs.4,500/- is being paid monthly to the family of the petitioner from September 2014 to till date.
- ii. A retrofitted scooter has been given to the petitioner Thiru A. Rajendran's family for taking the children to the school, as a special case
- iii. Based on the request made by the petitioner to the Collector, Tiruvannamalai District, a Special Toilet (Western Type) has also been constructed at the house of Thiru A. Rajendran for the use of children from the Collector's Discretionary Fund.

4. The State Commissioner for the Differently Abled has further stated that whatever the benefits available as per the schemes announced by the Government have already been granted to the family of Thiru A. Rajendran.

5. The State Commissioner for the Differently Abled, have already been provided Government benefits to the family. Further, the State Commissioner for the Differently Abled has requested to decide on providing other Special assistance to him at Government level. The Special Officer, Chief Minister Special Cell has recommended "for sanctioning an amount not lesser than Rs.3.00 lakhs" to Thiru A. Rajendran, as a special case.

6. The Government after careful consideration, sanction a sum of Rs.1.00 lakh per differently abled child, totaling Rs.3.00 lakhs (Rupees Three lakhs only) from the Chief Minister Public Relief Fund considering the hardships being faced by the family of Thiru A. Rajendran, of Tiruvannamalai District, as a Special case.

7. The Deputy Secretary to Government and Treasurer, Finance (CMPRF) Department is requested to send a cheque for a sum of Rs.3.00 lakhs (Rupees Three lakhs only) to the State Commissioner for the Differently Abled, Chennai-78.

8. The State Commissioner for the Differently Abled is requested to deposit the amount in a Nationalised Bank in his name so that nobody can draw the deposit without his knowledge. He is also authorized to issue standing instruction / intimation to the Bankers to send the monthly interest/ warrant directly to the parents / legal Guardian of the children.

9. This order issues with the concurrence of the Finance Department vide its U.O.No.19844/Fin(CMPRF)/2017, dated 19.04.2017.
