ORDER:

In the Order first read above, Government have issued orders, for continuance of the scheme of the Early Intervention Centre for children with cerebral palsy at Trichirapalli for the year 2016-17 and sanctioned a sum of Rs.7,02,000/-.

- 2. In the letter second read above, the State Commissioner for the Differently Abled has sent a proposal to Government for continuance of the scheme of Early Intervention Centre for children with cerebral palsy at Tiruchirappalli for the year 2017-18 and requested to sanction a sum of Rs.7,02,000/- for continuance of the scheme.
- 3. The Government after careful examination of the proposal of the State Commissioner for the Differently Abled have decided to accept the proposal and issue the following orders:
 - i. The State Commissioner for the Differently Abled is permitted to continue and implement the scheme of Early Intervention Centre for children with Cerebral Palsy at Tiruchirappalli through Non Governmental Organisations for the year 2017-18 and also sanction, a sum of Rs.7,02,000/- (Rupees Seven lakhs and two thousand only) as detailed in the annexure to this order.

- ii. The State Commissioner for the Differently Abled may decide on the selection and removal of the implementing Non Governmental Organisation with concurrence of the Government.
- iii. The State Commissioner for the Differently Abled is permitted to draw and disburse the amount to the implementing Non Governmental Organisation through District Differently Abled Welfare Officer, Tiruchirappalli, on half yearly basis.
- 4. The expenditure sanctioned at para 5 above shall be debited under the following Head of Account:-

"2235- Social Security and Welfare-02. Social Welfare-101- Welfare of Differently Abled Persons-State Expenditure-DE-State Resource cum Training Centre- 09 Grants in Aid-03 Grants for Specific Schemes". (DP Code:2235 02 101 DE-0935)
