#### ORDER:

In Government Order first read above, the Government had sanctioned a sum of Rs.2,82,000/- towards to Early Intervention Centre for children with Autism at Siragugal Special School in Thanjavur District for the year 2016-17.

- 2. In second read above, the State Commissioner for the Differently Abled has requested to government to sanctioned a sum of Rs.2,82,000/- and permitted to continue to run the Early Intervention Centre for children with Autism at Siragugal Special School, Thanjavur District for the year 2017-2018.
- 3. The Government have examined the proposal of the State Commissioner for the Differently Abled and issue the following orders:-
  - The State Commissioner for the Differently Abled to the scheme is permitted to continue to run the Early Intervention Centre for children with Autism at Siragugal Special School, Thanjavur District.
  - ii. Sanction is accorded for incurring an expenditure of Rs.2,82,000/- (Rupees Two lakhs and eighty two thousand only) as detailed below:-

- iii. To permit the State Commissioner for the Differently Abled to decide on the selection and removal of implementing the Non Governmental Organisation with the concurrence of Government.
- iv. To permit the State Commissioner for the Differently Abled to draw and disburse the amount to the present implementing Non Governmental Organisation namely, Siragugal Special School, Thanjavur District on quarterly basis.
- 4. The expenditure sanctioned in para 3 (ii) above, shall be debited under the following head of account:-

"2235-Social Security and Welfare-02 Social Welfare-101-Welfare of Differently Abled Persons-State's Expenditure - MX- Assistance to NGO's for Special Institutions for Children with Autism-09-Grants-in-Aid 03- Grants for Specific Schemes."
