ORDER:

In Government Order first read above, Government has sanctioned a sum of Rs.2,68,000/- as grant towards Early Intervention Centre for Hearing Impaired run by the Little Flower Convent Higher Secondary School for the Deaf, Chennai, for the year 2015-16.

2. Now, the State Commissioner for the Differently Abled has submitted proposal for sanction of a sum of Rs.1,48,000/- for the year 2016-17 for the Early Intervention Centre for Children with Hearing Impairment at Little Flower Convent for the Deaf.

3. The Government have carefully examined the proposal of the State Commissioner for the Differently Abled and decided to accord sanction for a sum of Rs.1,48,000/- (Rupees One lakh and forty eight thousand only) as grant to Little Flower Convent for the Deaf, Chennai under the scheme of Early Intervention Centre for Hearing Impaired for the year 2016-17, as detailed below:-
