#### **ORDER:**

Sub section(1) of section 79 of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016) envisages that, the State Government may, by notification, appoint a State Commissioner for Persons with Disabilities (hereinafter referred to as the "State Commissioner") for the purpose of that Act. The State Commissioner for Differently Abled has, therefore, requested to notify the State Commissioner for the Differently Abled as the State Commissioner for Persons with Disabilities as per Section 79(1) of the Rights of Persons with Disabilities Act for the purpose of this Act and issue orders in this regard.

- 2. The Government after careful examination of the proposal of the State Commissioner for the Differently Abled, decided to accept the proposal. Accordingly, the appended Notification will be published in the <u>Tamil Nadu Government Gazette</u>.
- 3. The Works Manager, Government Central Press, Chennai-79 is requested to publish the appended Notification in the <u>Tamil Nadu Government Gazette</u> and send one hundred copies of the Gazette to the Government for reference and record.
