## **ORDER:**

In the Government Order first read above, orders were issued for continuance of the scheme of “Early Intervention Centre for children with Autism” at State Resource cum Training Centre at Chennai for the year 2016-17 and sanction was accorded for a sum of Rs.2,82,000/-.

2. In the letter second read above, the State Commissioner for the Differently Abled has sent a proposal for the continuance of the “Early Intervention Centre for children with Autism” at State Resource-Cum-Training Centre for the year 2017-18 at a cost of Rs.2,82,000/-

3 The Government have examined the proposal of the State Commissioner for the Differently Abled and issue the following orders:-

- i. The State Commissioner for the Differently Abled is permitted to continue to run “Early Intervention Centre for children with Autism” at State Resource-Cum-Training Centre, K.K. Nagar, Chennai for the year 2017-18.
- ii. Financial sanction is accorded for incurring an expenditure of Rs.2,82,000/- (Rupees Two lakhs and eighty two thousand only) to continue to implement the “Early Intervention Centre for children with Autism” scheme for the year 2017-18 as detailed below:-

- iii. To permit the State Commissioner for the Differently Abled to draw and disburse the amount to the present implementing Non Governmental Organisation namely, State Resource cum Training Centre for Autism at Chennai District on quarterly basis.
- iv. The State Commissioner for the Differently Abled is permitted to decide on the selection and removal of the implementing Non Governmental Organisation in consultation with the Government.

4. The expenditure sanctioned in para 3 (ii) above shall be debited under the following head of account:-
