ORDER:

As per section 33(i) of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016) "the appropriate Government shall identify posts in the establishments which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved in accordance with the provisions of section 34" of the said Act.

2. In the Government orders second, third, fourth and fifth read above, orders were issued identifying the post of Assistant Engineer (Civil) in various departments as suitable for differently abled persons under 4% reservation as follows:-

After careful examination, the Government decided to accept the request of the Commissioner for Welfare of the Differently Abled and accommodate the categories of Differently Abled Persons identified for the post of Assistant Engineer (Civil) in Tamil Nadu Adi Dravidar Housing & Development Corporation Limited by direct recruitment under 4% reservation as classified below:-
