### **ORDER:**

In the Government Order first read above, sanction was accorded for a sum of Rs.80,00,000/- towards construction of new building measuring 5300 sq.ft for the Office of the State Commissioner for the Differently Abled in the campus of State Resource cum Training Centre.

2. In the Government Order second read above, orders were issued to divert the earmarked amount of Rs.80,00,000/- (Rupees eighty lakhs only) which was originally sanctioned for the construction of School and Hostel building for the Government School for the Deaf at Pudukottai under Part-II Scheme for the year 2011-2012 to construct the office building for the Office of the State Commissioner for the Differently Abled, in addition to the amount of Rs.80,00,000/- which was already sanctioned under Part-II Scheme 2011-2012.

3. In the Government Order third read above, orders have been issued for transferring an extent of 10 grounds and 35 sq.ft. out of the total extent of 2 Cawnie 6 Grounds 113 sq.ft. classified as Government Revenue Department in R.S.No.973/1 in Mylapore village, Mylapore-Triplicane Taluk, Chennai District to the Department for the Welfare of the Differently Abled for the construction of the office building, subject to usual terms and conditions laid down under RSO 23(a) free of cost.

4. In the Government Order fourth read above, orders were issued to accord Revised Administrative Approval for a sum of Rs.1,63,90,000/- and financial sanction for an additional amount of Rs.3,90,000/- for the construction of the building (Ground Floor, First Floor and Head Room in Second Floor) for the Office of the Commissionerate for the Welfare of Differently Abled Persons in Lady Wellington College Campus at Triplicane, Chennai-5.

5. In the letters fifth read above, the State Commissioner for the Differently Abled has stated that the above mentioned land has been transferred to Department for the Welfare of the Differently Abled Persons for the construction of the office. This land has been handed over to Assistant Executive Engineer, Construction Wing (PWD) land for construction of the Office building. The Public Works Department has also commenced the construction work which is under progress.

6. The State Commissioner for the Differently Abled has also stated that the Chief Engineer (Buildings) has been requested to prepare an estimate for construction of first floor (partly) and second floor for the office of the Commissionerate for the Welfare of Differently Abled in the Lady Wellington College Campus, Triplicane. Accordingly, the Executive Engineer, Public Works Department, Buildings Construction Division-1, Chepauk has submitted the estimation for the construction of first floor (partly) and second floor for the office of the Commissionerate for the Welfare of the Differently Abled in the Lady Wellington College Campus, Triplicane at a cost of Rs.1,25,00,000/- for the year 2014-15 and Rs.1,37,50,000/- for the year 2015-16. He has, therefore, requested to accord administrative and financial sanction for sum of Rs.1,25,00,000/- for the year 2014-15 and Rs.1,37,50,000/- for the year 2015-16.

7. The Government have examined the proposal of the State Commissioner for the Differently Abled carefully along with administrative proposal / estimate and decided to accept the same. Accordingly, Government accord administrative and financial sanction for an amount of Rs.1,30,00,000/- (Rupees one crore and thirty lakhs only) (2014-15 rate Rs.125 lakh + 4% growth for 2015-16) for extension works for construction of first floor (partly) and second floor for the Office of the State Commissioner for the Differently Abled in the Lady Wellington College Campus, Triplicane, Chennai for the financial year 2015-16.

8. The above amount sanctioned in para 7 shall be debited under the following head of account:

**“4235 – Capital outlay on Social Security and Welfare – 02-Social Welfare – 101 –Welfare of Handicapped - Schemes in the Twelfth Five Year Plan – II– State Plan – JU – Buildings – 16 – Major Works (D.P.C. 4235 02 101 JU 1601)”**

9. The expenditure shall be treated as “New Instrument of Service” and the approval of Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimate for the year 2015-2016. Pending approval of Legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Building), Public Works Department is directed to calculate the actual amount required for the period upto next supplementary estimate and apply for sanction of the same as advance from the Contingency Fund to Finance (PGI)

Department directly in Form-A appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from the Finance (BG-I) Department.

10. The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai is directed to send necessary explanatory note to include this expenditure in the Supplementary Estimate 2015-2016 Finance (PW-I/SW) Department, without fail.

11. After completion of work, the State Commissioner for the Differently Abled is requested to furnish the work completion certificate to the Government obtained from the Public Works Department.

In the Government Order first read above, sanction was accorded for a sum of Rs.80,00,000/- towards construction of new building measuring 5300 sq.ft for the Office of the State Commissioner for the Differently Abled in the campus of State Resource cum Training Centre.

2. In the Government Order second read above, orders were issued to divert the earmarked amount of Rs.80,00,000/- (Rupees eighty lakhs only) which was originally sanctioned for the construction of School and Hostel building for the Government School for the Deaf at Pudukottai under Part-II Scheme for the year 2011-2012 to construct the office building for the Office of the State Commissioner for the Differently Abled, in addition to the amount of Rs.80,00,000/- which was already sanctioned under Part-II Scheme 2011-2012.

3. In the Government Order third read above, orders have been issued for transferring an extent of 10 grounds and 35 sq.ft. out of the total extent of 2 Cawnie 6 Grounds 113 sq.ft. classified as Government Revenue Department in R.S.No.973/1 in Mylapore village, Mylapore-Triplicane Taluk, Chennai District to the Department for the Welfare of the Differently Abled for the construction of the office building, subject to usual terms and conditions laid down under RSO 23(a) free of cost.

4. In the Government Order fourth read above, orders were issued to accord Revised Administrative Approval for a sum of Rs.1,63,90,000/- and financial sanction for an additional amount of Rs.3,90,000/- for the construction of the building (Ground Floor, First Floor and Head Room in Second Floor) for the Office of the Commissionerate for the Welfare of Differently Abled Persons in Lady Wellington College Campus at Triplicane, Chennai-5.

5. In the letters fifth read above, the State Commissioner for the Differently Abled has stated that the above mentioned land has been transferred to Department for the Welfare of the Differently Abled Persons for the construction of the office. This land has been handed over to Assistant Executive Engineer, Construction Wing (PWD) land for construction of the Office building. The Public Works Department has also commenced the construction work which is under progress.

The State Commissioner for the Differently Abled has also stated that the Chief Engineer (Buildings) has been requested to prepare an estimate for construction of first floor (partly) and second floor for the office of the Commissionerate for the Welfare of Differently Abled in the Lady Wellington College Campus, Triplicane. Accordingly, the Executive Engineer, Public Works Department, Buildings Construction Division-1, Chepauk has submitted the estimation for the construction of first floor (partly) and second floor for the office of the Commissionerate for the Welfare of the Differently Abled in the Lady Wellington College Campus, Triplicane at a cost of Rs.1,25,00,000/- for the year 2014-15 and Rs.1,37,50,000/- for the year 2015-16. He has, therefore, requested to accord administrative and financial sanction for sum of Rs.1,25,00,000/- for the year 2014-15 and Rs.1,37,50,000/- for the year 2015-16.

7. The Government have examined the proposal of the State Commissioner for the Differently Abled carefully along with administrative proposal / estimate and decided to accept the same. Accordingly, Government accord administrative and financial sanction for an amount of Rs.1,30,00,000/- (Rupees one crore and thirty lakhs only) (2014-15 rate Rs.125 lakh + 4% growth for 2015-16) for extension works for construction of first floor (partly) and second floor for the Office of the State Commissioner for the Differently Abled in the Lady Wellington College Campus, Triplicane, Chennai for the financial year 2015-16.

8. The above amount sanctioned in para 7 shall be debited under the following head of account:

sanction of the same as advance from the Contingency Fund to Finance (PGI) Department directly in Form-A appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from the Finance (BG-I) Department.

10. The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai is directed to send necessary explanatory note to include this expenditure in the Supplementary Estimate 2015-2016 Finance (PW-I/SW) Department, without fail.

11. After completion of work, the State Commissioner for the Differently Abled is requested to furnish the work completion certificate to the Government obtained from the Public Works Department.
