#### ORDER:

In the Government Order first read above, orders were issued for continuance of the scheme of Early Intervention Centres for children with Mental Retardation in 31 Districts for the year 2016-17 and also sanctioned a sum of Rs.2,12,04,000/-.

In the letter second read above, the State Commissioner for the Differently Abled has sent a proposal to Government for continuance of the scheme of Early Intervention Centre for Children with Mental Retardation in 31 Districts for the year 2017-18 and requested to sanction an amount of Rs.2,12,04,000/-.

3. The Government, after careful examination, has decided to accept the proposal of the State Commissioner for the Differently Abled and issue orders as follows:-

i. Permission is accorded to the State Commissioner for the Differently Abled for the continuance of the scheme of Early Intervention Centre for Children with Mental Retardation in 31 Districts for the year 2017-18 and also, sanction is accorded for a sum of Rs.2,12,04,000/- (Rupees Two crores twelve lakhs and four thousand only) as detailed in below:-

- ii. Permission is also accorded to decide on the removal and selection of implementing Non Governmental Organisations, after observing due formalities and principles of natural justice in consultation with Government.
- iii. The grants to the Non Governmental Organisations shall be released on quarterly basis as per existing procedure.
