## ORDER:

In the Government Order first read above, the Government have permitted the State Commissioner for the Differently Abled to establish, an Early Intervention Centre for children with Autism at Kanniyakumari and to be managed by REJOICE School for Autism and Developmentally Delayed, Nagercoil, Kanniyakumari district and sanctioned a sum of Rs.2,82,000/-.

2. In the letter second read above, the State Commissioner for the Differently Abled has requested to continue an Early Intervention Centre for Autism, in Kanniyakumari District through a Non Governmental Organisation, (viz) REJOICE School for Autism and Developmentally Delayed and requested to sanction a sum of Rs.2,82,000/- for the year 2016-2017.

3. The Government have carefully examined the proposal of the State Commissioner for the Differently Abled and issue following orders:-

- i. The State Commissioner for the Differently Abled is permitted for the continuance of the Early Intervention Centre for Autism at Kanniyakumari District through a Non Governmental Organisation(viz)REJOICE School for Autism and the Developmentally Delayed, Nagarcoil, Kanniyakumari District .
- ii. Sanction is accorded for incurring an expenditure of Rs.2,82,000/- (Rupees Two lakhs and eighty two thousand only) as detailed below:-

- iii. To permit the State Commissioner for the Differently Abled to draw and disburse the amount as an advance to the present implementing Non Governmental Organisation namely, REJOICE School for Autism at Kanniyakumari District.
- iv. To permit the State Commissioner for the Differently Abled to decide on the selection and removal of implementing the Non Governmental Organisation with the concurrence of Government

4. The expenditure sanctioned at para 3(ii) above shall be debited under the following head of account:-

2235-Social Security and Welfare-02 Social Welfare-101-Welfare of Differently Abled Persons-Schemes in the twelfth five year plan-II State Plan- MX- Assistance to NGOs for Special Institutions for children with Autism-09-Grants-in-Aid 03-Grants for Specific Schemes.

5. Necessary Funds will be provided in RE/FMA 2016-17. Pending provision of such funds, State Commissioner for the Differently Abled Department is authorized to draw and disburse the amount sanctioned in para -3(ii) above and the State Commissioner for the Differently Abled Department is also requested to include the expenditure while sending the proposal for RE/FMA 2016-17 to Government in Finance (SW) Department without fail.
