## ORDER:

In Government Order first read above, orders were issued giving administrative approval to the State Commissioner for the Differently Abled to appoint a consultancy firm to study and to implement the end to end solutions for computerization of the departmental activities in consultation with ELCOT.

- 2. In the letter second read above, the State Commissioner for the Differently Abled has stated that orders have been issued for computerisation of the Welfare of Differently Abled Persons Department and to appoint a Consulting Agency. Administrative sanction has also been given for a sum of Rs.25.00 lakhs to study and implement the end to end solution for computerization of Departmental activities in consultation with ELCOT. Accordingly the ELCOT has been informed vide his office Proceedings No.3939/SO/2015, dated 19.06.2015 about the detailed instructions issued in Government Order first read above, with the request to send the suitable consultancy firm to study the requirement for implementing end to end solution for computerisation of this Departmental activities, along with cost of expenditure. Subsequently the ELCOT has selected the Agency M/s. Perisoft and submitted the cost of expenditure for Rs.24,91,606/-
- 3. Now, the State Commissioner for the Differently Abled has requested to Government accord sanction of Rs.24,91,606/- for the computerisation of the departmental activities.

- 4. The Government have examined the proposal carefully, and accord sanction for a sum of Rs.24,91,606/- (Rupees Twenty Four lakh ninety one thousand six hundred and six only) for the implementation of end-to- end solutions for the computerisation of the departmental activities.
- 5. The expenditure sanctioned at para 4 above shall be debited under the following Head of Account:-
  - "2235- Social Security and Welfare 02. Social Welfare 001- Direction and Administration-I Non Plan AF- Commissionrate for the Welfare of Differently Abled Persons –33- payment for Professional and Special Services-03 Special Services. (D.P. Code 2235-02-001-AF-3337)
- 6. The State Commissioner for the Differently Abled, Chennai-78 is authorized to draw and disburse the amount sanctioned in para -4 above.
- 7. This order issues with the concurrence of the Finance Department vide its U.O. No.39355/Fin(SW)/2016, dated 02.08.2016.
