ORDER:

In the Government Order first read above, orders were issued enhancing the monthly maintenance allowance from Rs.1000/- to Rs.1500/- for 6166 leprosy affected persons from June, 2017.

2. In the Government Order second read above, orders were issued sanctioning a sum of Rs.17,48,000/- towards monthly maintenance allowance at Rs.1,000/- per person for 437 leprosy affected persons for the period from February, 2017 to May, 2017.

3. In the letters third read above, the State Commissioner for Differently Abled has stated that based on the availability of funds, sanction was accorded to District Differently Abled Welfare Officers to incur a sum of Rs.10,37,29,500/- towards maintenance allowance to the beneficiaries affected with leprosy. The total number of beneficiaries in September, 2017 waiting list is 383 and the additional funds required is Rs.40,21,500/- i.e 383 beneficiaries x Rs.1500/- x 7 months (September 2017 – March, 2018). He has therefore requested to sanction an additional amount of Rs.40,21,500/- towards 7 months maintenance allowance from September, 2017 to March, 2018 to 383 waiting list leprosy affected persons in the Revised Estimate 2017-2018 and permit him to incur the above amount pending inclusion in the Revised Estimate 2017-2018.

4. After careful examination of proposal of the State Commissioner for Differently Abled, the Government have decided to accept and accord sanction for sum of Rs.40,21,500/- (Rupees forty lakhs twenty one thousand and five hundred only) towards the maintenance allowance @ Rs.1,500/- per months from September, 2017 to March 2018 (7 months) for the newly identified 383 leprosy affected persons.

5. The amount sanctioned in para 4 above, shall be debited under the following head of account:

“2235 – Social Security and Welfare-02 – Social Welfare-104 – Welfare of aged infirm and destitute – State’s Expenditure – KQ – Maintenance Allowance to Leprosy Affected Persons-09 – Grants in aid-03 – Grants for specific schemes”.
